SUBJECT: Italian Army Interpreters.

TO : Commanding General, Rome Area Allied Command,
APO 794.

1. Reference is made to RAAC/117/03 Br) dated 2 February 1945.

2. It is desired that all Liaison Sections of the Italian Army attached to Allied Headquarters should be organized on WE/TOs.

3. Request information as to whether the Liaison section referred to in your letter is engaged (a) as a mission acting on behalf of the Italian Authorities, or in the service of either (b) the British Staff of RAAC (c) the US Staff of RAAC or (d) equally in the service of both British and US Staffs.

4. All Liaison Staffs working on behalf of the Allies will be included within the WE/TO of an AFHQ Italian Interpreter and Liaison Pool. If the unit is within category (b) (c) or (d) in paragraph (2) above, you are requested to forward a proposed unattached interpreter or liaison personnel of the Italian Army now within RAAC.
