Italian Liaison, G4 - Fifth Army - info

In compliance with the instructions issued by MMIA, the units of the division are being allotted to other outfits gradually and in a short time.

It is necessary to consider ~~many~~ such a proceeding in regard both to record administrative and to moral reasons . In order to obviate the inconveniences arisen owing to this situation, as furthermore there are no depots to which turn in all the pending questions, it is felt necessary to form some administrative record offices according to the proposals listed below . As far as the morale is concerned it is pointed out that the moral patrimony acquired during the campaign of liberation must be safeguarded in the highest degree particularly at the present time. This is also related to the instructions issued by the Ministry of War - Welfare office - with letters 06339/BS and 06250/BS dtd 31 and 26 July 1945. It should be furthermore considered that for each soldier of the division a certificate of commendation will be filled, for his performance with 5th Army .

The organization of the administrative record offices is therefore needed for settling the following matters :

1. Morale

- a. Issue to every soldier of the Division, included the discharged personnel, of the certificate of commendation and of the other certificates referred to in the letter 01/2460 dtd 30 July 1945 of this HQ .
- b. Assistance to the discharged personnel according to the instructions of the Ministry of War (letter 06339/BS) .
- c. Settlement of the questions concerning the awards for valor, the "croci di guerra" for merit and the ribbon of the campaign of

the units of the division are being allotted to other outfits gradually and in a short time.

It is necessary to consider ~~many~~ such a proceeding in regard both to record administrative and to moral reasons.

In order to obviate the inconveniences arisen owing to this situation, as furthermore there are no depots to which turn in all the pending questions, it is felt necessary to form some administrative record offices according to the proposals listed below.

As far as the morale is concerned it is pointed out that the moral patrimony acquired during the campaign of liberation must be safeguarded in the highest degree particularly at the present time. This is also related to the instructions issued by the Ministry of War - Welfare office - with letters 06339/BS and 06250/BS dtd 31 and 26 July 1945. It should be furthermore considered that for each soldier of the division a certificate of commendation will be filled, for his performance with 5th Army.

The organization of the administrative record offices is therefore needed for settling the following matters:

1. Morale

- a. Issue to every soldier of the Division, included the discharged personnel, of the certificate of commendation and of the other certificates referred to in the letter 01/2460 dtd 30 July 1945 of this HQ.
- b. Assistance to the discharged personnel according to the instructions of the Ministry of War (letter 06339/BS).
- c. Settlement of the questions concerning the awards for valor, the "croci di guerra" for merit and the ribbon of the campaign of liberation.
- d. Good settlement of the graves which owing to the events, ~~are spread~~ from the Garigliano to the Po.

2. Record

- a. Settlement with the mobilization centers of the matters concerning ~~administrative~~ the transfers which, for many soldiers, have been numerous.
- b. Settlement of the questions concerning the missing in action and the wounded personnel.
The settlement of above questions (para a and b) is very complicated as this Division, during its advance towards northern Italy, has been attached, for administrative purpose to four Territorial Headquarters.
- c. Settlement, with the organization and mobilization office of the SMRE of all the questions concerning the disbandment of the HQs and the units of the Division.

3. Administration.

a. Settlement of all the administrative questions, many of which related to requisitions, indemnifications etc. It is to be remembered that the administrative autonomy was generally granted to all the battalions and, for the pack mule outfits, to all the pack companies.

b. Settlement of all the question concerning motor vehicle materiel and any other kind of materiel.

According to what stated above it is felt necessary that the following be authorized :

1. the maintaining of HQ and Pq Co, 210th Division, with the T/O showed in appendix A.
2. the organization , for each regiment under command, of an administrative record office with the T/O showed in appendix B and C.
3. the maintaining , with reduced T/Os, of the following services of the Division :
 - 210th Transport Co (which after the withdrawal of the US. equipment and the discharges will have about 25 trucks, 3 officers and 80 EM, including the ordnance platoon)
 - 210th Barron and Clothing Platoon reduced to a Group of three officers and 25 EM, to be kept operating at Peschiera for all the elements which will remain
 - 154th Royal Carabinieri Section reduced to a strength of 1 officer and 20 Carabinieri.

1. the maintaining of HQ and Hq Co, 210th Division, with the T/O showed in appendix A.
2. the organization, for each regiment under command, of an administrative record office with the T/O showed in appendix B and C.
3. the maintaining, with reduced T/Cs, of the following services of the Division:

- 210th Transport Co (which after the withdrawal of the US. equipment and the discharges will have about 25 trucks, 3 officers and 80 EM, including the ordnance platoon)
- 210th Eation and Clothing Platoon reduced to a Group of three officers and 25 EM, to be kept operating at Peschiera for all the elements which will remain
- 154th Royal Carabinieri Section reduced to a strength of 1 officer and 20 Carabinieri.

It is furthermore kindly requested that it be allowed to leave in the billet of the Rome staging area (which will be disbanded) Major VIOLA, C.O. of the staging area, with 5 EM for Liaison purpose between this Hq and the agencies of the Ministry of War. He is an officer well acquainted with all the problems of the Division and who may be useful for the settlement of all the question which will arise.

It will be my care to inform you about the date after which the proposed offices will no more be needed in order to proceed to their disbandment.

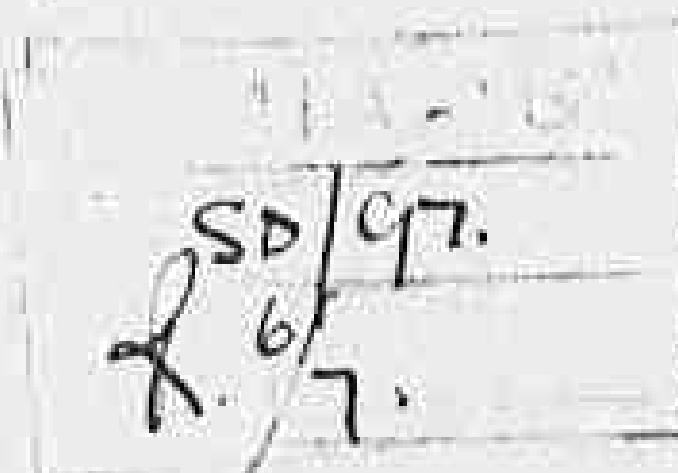
