1. The above transit camp, strength 3 officers (including a Lt Col) and 5 other ranks has been visited recently by an officer from this HQ.
2. He reports that the camp was recently set up to accept military personnel coming from the BALKANS and has accommodation and casernaggio equipment for 400 men, but has never, in fact, been called upon to accommodate any men and due to the decreasing number of men returning from the BALKANS it is apparent that this camp is unnecessary.
3. It is understood by WHIA that the Military Barracks at Castellana are earmarked for repatriated personnel as and when needed, (your letters 400350/RPGR of 24 Nov 44 and 400526/RPGR of 3 Dec refer). No authority has been granted, however, for assigning Nil personnel or stores to any of the barracks or accommodation reserved for this purpose.
4. You are requested to close this camp forthwith returning all casernaggio equipment to the Bari Depot. Other ranks personnel will be despatched to TRANI Camp and officer personnel disposed of under your own arrangements.
5. Advise WHIA when the above instructions have been carried out.

1. From the attached copies of correspondence received on the activities of Capt GAY, it will be seen that this officer of doubtful record has been illicitly and illegally enlisting Italian soldiers, already serving in Combat Groups and other units, into "F" Recce Sqn, 1867.
2. This unauthorised enlistment, which takes the form of inciting men to desert from their units has not only been restricted to one Combat Group. Both the BRILLI and LEGNANO Groups have reported desertions following the visits of Captain GAY or his collaborators.
3. The conduct of this officer is now being strongly taken up with the War Ministry. It has always been my opinion that private bands, "patriotic" or otherwise, are a menace to the efficiency of the Italian Army as a whole and this view has been fully reported to you in my letter 15/6/19 of 27 Dec 44.
4. In view of the present shortage of reinforcements, I strongly recommend that "F" Recce Squadron and the Banda MAIELLA be disbanded and made available for filling the Allied programme as under:-

- (a) "F" Recce Sqn ----- to CESANO as Combat Gp Rfts
- (b) Banda MAIELLA ----- to ORVETO as Muleteers.

2. This unauthorized enlistment, which takes the form of inciting men to desert from their units has not only been restricted to one Combat Group. Both the MIOLI and LEGHANO Groups have reported desertions following the visits of Captain GAY or his collaborators.

3. The conduct of this officer is now being strongly taken up with the War Ministry. It has always been my opinion that private bands, "patriotic" or otherwise, are a menace to the efficiency of the Italian Army as a whole and this view has been fully reported to you in my letter IS/G/19 of 27 Dec 44.

4. In view of the present shortage of reinforcements, I strongly recommend that "F" Recce Squadron and the Banda MALINIA be disbanded and made available for filling the Allied programme as under:-

- (a) "F" Recce Sqn ----- to ORSANO as Combat Op Bn
- (b) Banda MALINIA ----- to ORVINO as Muleteers.

1. Ref your HQ signals SS501, 502, 503 of 27 Dec 44.
2. The question of desertion from Combat Gp POLCORE is being investigated and a report will be submitted to your HQ in due course.
3. I visited 51 BLU immediately before Xmas and was informed by them that Combat Gp CREMONA had experienced an unduly large number of deserters since moving to their new location. It is obviously essential to prevent this happening as far as is possible with Combat Gp POLCORE.
4. Early this month enquiries were made at this HQ by 78 Section S.I.B., ABHQ re the whereabouts of a Captain Gay of the Italian Army who it was desired to interrogate in connection with a war crime.
5. Enquiries were made immediately and the two attached reports were submitted, 4003 by the Combat Gp.
6. It is considered that every effort should be made to obtain the return of any men found with "F" Recce Regt who are deserters from Combat Gp POLCORE and on their return it will be arranged that they are dealt with severely.
7. Please inform this HQ if any assistance can be given in this matter.

SUBJECT: Captain Gay

TO : Hq Combat Group FOLGORE

INRM : Hq "MEMBO" Parachute Regt

With reference to your telephone request I communicate the following:-

(a) It does not appear that Captain Gay has been seen in this area.

(b) On 16 Nov Lt Aldo Trincas at present working with the "F" Recce Unit introduced himself asking if he could take 300 automatic rifle magazines. With the said officer was Sgt Piero Piatti who was absent without leave from the Bn 18 Oct 44 and had joined the strength of the "F" Recce Unit.

When the lorry set off, some soldiers of the Bn, a few carrying complete kit and others blankets, went off with it. The matter was discovered and the lorry was stopped at Telesse, and 2/Lt Trincas with the soldiers returned to the Bn. Questioned, a few admitted that they wished to join the "F" Recce Unit and others denied such a proposition.

Sgt Piatti was arrested by me and put in the local prison, he has since been released and has again joined the "F" Recce Unit in accordance with the Regt order.

(c) On 25 Nov 2/Lt Ganzini and 2/Lt Scaranari both of the "F" Recce Unit came to find men to join the unit. Some officers deplored this form of encouragement that the "F" Recce Unit offers to soldiers willing to go. The two officers answered that they had need to make up for the losses and that however from time to time they had authority from the General Staff.

From 16 Nov (date of arrival of 2/Lt Trincas) up till today 20 soldiers have absented themselves (see list attached) and it may be presumed that most of them have gone to the "F" Recce Unit. Amongst these is the Parachutist Camiciottoli who had tried to absent himself on 16 Nov in 2/Lt Trincas' lorry.

Some soldiers had English clothes and arms. Other previous absentees were found at the "F" Recce Unit.

(d) It is not certain that real propaganda was used to instigate the soldiers to join the "F" Recce Unit but on the contrary were skilfully were made known the advantages which the men of the said unit would enjoy: rations of English troops, possibility of leave and frequent passes, plenty of transport, situated in a locality where the men could enjoy themselves to the fullest extent.

Indeed during the period that the 185 Parachute Regt was working with the English Division in Tuscany, the soldiers of the "F" Recce Unit were continually making excursions to Florence on lorries and motorcycles.

(e) Captain Gay deserted from the Regt on 9 Sep 43 taking with him his company (8th of 3rd Bn) with armaments, equipment, money and transport etc.

During the inquest and after the questioning some soldiers of the Regt the following resulted:-

(1) That with the exception of the Bn CO and Coy COs, the other officers, NCOs and parachutists believed that they were all being used to attack the Germans again - only on the day 11 Sep, when every vehicle received a pass on which it was stated the 3rd Bn was to come under the direct command of the 26th German Division, did the soldiers understand the treachery of the COs and the Bn was disbanded -

(2) That Captain Gay and Rosano were the only two COs who during a conference held in the afternoon of 9 Sep at 'Soveria Mannella' by Captain Sala temporary CO of the 3rd Bn (the real CO was myself, but at that time I was temporary commander of the Regt) instigated the latter to follow the Germans, threatening him whenever he did not make a decision, they having the full support of their men would have abandoned him.

Captain Gay by order of the LI C.A. has been accused by the Military War Tribunal, Naples, for complicity in the following :-

- (a) Unauthorized movements of military forces.
- (b) Disobedience.
- (c) Abandoning the Corps to fight against the Italians.
- (d) Action detrimental to the operation of the Armed Forces.

The 3rd Bn of the NEMBO Parachutist Regt is constituted of personnel who belonged to 185 Para Regt, which in 1943 operated independently in SICILY and CALABRIA.

At the Armistice, one of those officers who united with the Germans, and brought pressure to bear to get a part of his own battalion to follow him, was Capt Gay who was then commanding 8 Coy.

Due to those activities he was denounced to War Military Tribunal in NAPLES in March 1944 (see Major Massimino's statement, copy of which was sent as apprx to 4177/Pers of 11 Dec).

This officer today would command a unit called 1st Sqn "F. Recce" Paratroopers the numbers of which would be in TUSCANY. He has worked up intense action within the Bn to get its soldiers to join his unit, where they would enjoy a treatment throughout identical to the troops of the United Nations.

The ORs who left the 3rd Bn turn out to have entered the above named unit; it appears certain re the Paratroopers LOVATTE Mario, COPPA Luigi and VALENTINI Primo. These men were denounced as deserters and of stealing the equipment they took with them.

On 16 Nov, professing to be calling for some empty LMG magazines, the a/m unit reported first to the Bn and then to the NEMBO Regt to an offr of the 1st Sqn, 2nd Lt TRINCAS Aldo. By watching over him and the vehicle in his charge, an attempt by several ORs to leave the Bn was thwarted.

Since this officer's activities of luring the men away could not be proven, the NEMBO Regt had to be content with having both officer and vehicle sent away immediately. In the period shortly after his leave (22 Nov - 7 Dec), in spite of vigilance arranged beforehand, 20 ORs deserted the Regt.

On 16 Nov, professing to be calling for some empty LMG magazines, the a/m unit reported first to the Bn and then to the NEMBO Regt to an offr of the 1st Sqn, 2nd Lt TRINCAS Aldo. By watching over him and the vehicle in his charge, an attempt by several ORs to leave the Bn was thwarted.

Since this officer's activities of luring the men away could not be proven, the NEMBO Regt had to be content with having both officer and vehicle sent away immediately. In the period shortly after his leave (22 Nov - 7 Dec), in spite of vigilance arranged beforehand, 20 ORs deserted the Regt.

Neither the deserters nor the truck, which was waiting somewhere in CAMPANIA to take them to the 1st Sqn could be traced through investigations carried out by the Dependent Commands and C.C.R.R.

The ORs who went away taking with them their weapons and equipment are being posted as deserters and accused of stealing military equipment. I arranged to have any theft of equipment reported to this ECU.

It will be advantageous if the competent authorities get the deserters to return, and that necessary steps be taken to prevent any similar cases of desertion in other formations taking place, particularly if these are, like Combat Gp FOLGOMI, intended for operations.

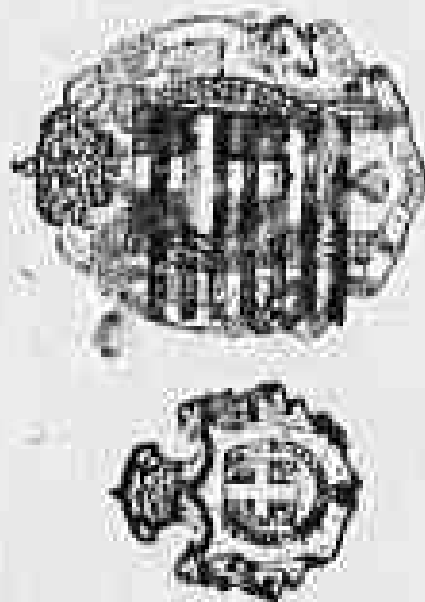

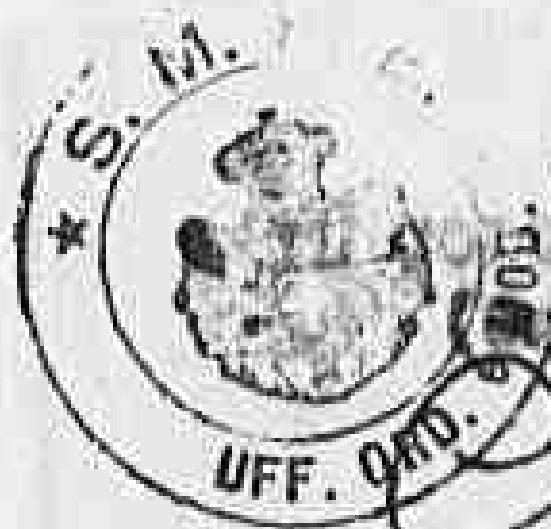

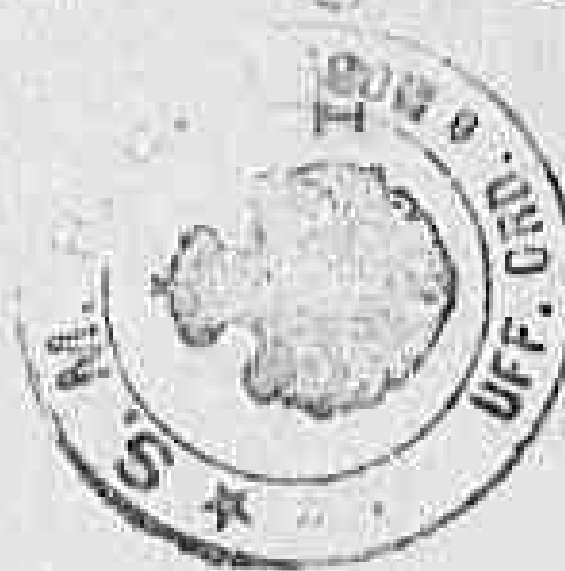
