2. The matter about the cutting of the Marked timber the Mandrianiello's Forestry Land of the National land Estates of Persano (Salerno) has been notified to the M.M.S.A. -Roma-

In agreement with the Land Forces Sub-Commission A.C. we have thought to sell the wood by auction among several competitor Firms in order to obtain the best possible conditions; For there are other Firms Equipped as well as the SADA Firm, that, for a long time have asked to get the direct allotment of the wood, or to be called on to tender. It is understood that the same SADA Firm will be called on to tender.
4. The wood obtained by cutting will be utilised in the most rational way for the needs of the National reconstitition.-
5. Meantime the SADA Firm for urgent needs will be able to try to get wood from other sources.-





1. During the months of November and December several withdrawals of machines, equipment, and raw materials (see enclosed list) were effected from the Italian Army Shell Factory for further consignment to various establishments.
2. In regard to this please note that it is impossible for us to state whether or not these movements were authorized by MMIA according to the orders in force.
3. If said movements were ordered by MMIA, we beg you to let us know, if possible, where said materials have been stored in order to facilitate eventual salvage operations.
