1. From Nominal Rolls of ranks and trades forwarded by you the attached statement has been prepared showing the apparent distribution of personnel in comparison with the WE and deficiencies and surpluses resulting
2. It is observed that DOS AFHQ has applied for reinforcements to complete the deficiencies and that these will be posted by you after undergoing training in the RAOC Training Establishment.
It is assumed that no action will be taken to dispose of surplus personnel until the deficiencies have been made up.
3. It is observed that nominal rolls of the personnel of this unit have now been despatched to GHQ 2nd Echelon. Will you please instruct HQ 381 Italian Ord Coy to despatch a Field Strength Return to 2nd Echelon as soon as possible and to arrange that this is done weekly thereafter.
4. It is observed that the HQ of 381 Italian Ord Coy will now be established at the MT Transit Depot CAPUA.
When the detachment of personnel intended for CAPUA finally move will you please ensure that the HQ does in fact move with it, and that the MT Transit Depot is aware of the personnel which constitute the HQ for administrative purposes.
May this office also be advised when the HQ is so established at CAPUA and application will then be made for the transport to complete the unit to WE.
5. In regard to equipment the contents of Para 5 of your letter are noted. As however applications are being received at this HQ through Staff Channels for equipment to be issued on temporary loan in order to maintain the present detachments, it is requested that an early reply may be given by you in order that the necessary Equipment Lists may be proposed and approved.

2. The Italian Ordnance personnel referred to are 331 Italian Ord Gen Stores Coy (4 Offrs and 121 ORs) plus an increment of 96 ORs.
3. 331 Coy moved to Capua on 19/10/44. (my TE/66 dated 19/10/44 addressed to C.I/o LT Transit Depot, copy to you refers). By arrangement with Lt.Col. Dansie, increments of 65 ORs and 31 ORs were sent on Oct 25th and Nov 1st respectively, to act as "humpers". These men were not trained Ord personnel; their low mentality made it impossible to train them as Clerks or Storemen so they were merely sent as surplus to W.E. of 331 Coy to act as labour.
4. Of the personnel on the list sent by 63 Grn Regt, RA, only 7 belong to 331 Coy, and I consider that OC 331 Coy should be capable of disciplining these 7 men. If you no longer require the 96 ORs (or as many as are left) for labour purposes I suggest you instruct OC 331 Coy to contact HQ 227 Div and have them returned to their Regiment as unsuitable for training for Ordnance (see para 3) and no longer required by you as labour.

 - (a) the Battledress in question was dyed under a contract made by DDOS L of C and was issued from the Clothing Factory under his authority, (not from the Italian Army Dyeing Plant).
 - (b) the state of Italians arriving here from Afragola was deplorable; not only were they badly clad but, they were lousy and something much quicker than the cumbersome method extant for equipping them had to be found.
 - (c) not only was Battledress obtained but under-Clothing, socks, towels were also made available with the result that
 - (i) Afragola camp was cleared quicker than would otherwise have been the case and the morale of some 500 Italian soldiers, who were quickly degenerating into something sub-human, was improved out of all knowledge.
 - (ii) men were trained in Ordnance duties and sent out to work quickly, thereby relieving the man-power situation.
 - (d) these issues were made under the authority of DDOS L of C and if similar circumstances arise in future the same action will be taken.
