3. In view of the fact that it is the responsibility of the District to maintain Unit lists of excess VEHs and Bgts, say to be informed of the system initiated by you with the MOB and Veh Pks, for notifying this office of items returned.

4. It is considered that the system as formulated in a/q letter is liable to lead to considerable complications and may involve the employing of a large proportion of Area and District Staffs on very detailed work. As every effort has been, and is being made to reduce Staffs etc at this juncture, the following suggested simplified method is put for your consideration:-

All Stores now held by Co-operator Units should be transferred to AREA through the medium of a consolidated Voucher from each Unit. This Voucher could be priced by AREA/HEADQUARTERS of AREA/ Sub Areas concerned, and AREA to debit the Italian Government accordingly. At the time of the final cancellation of the

British Army in Italy, all stores then held by MIA can be placed on a consolidated Voucher priced, and returned to Finance. MIA to credit Italian Government accordingly.
