2. CO 410 Ital.Pnr. Reg. has not yet received any instructions for disbandment of 306 and 304 Ital.Pnr.Coys at Prato and Florence respectively.
3. It would be appreciated if immediate liquidation of 304 and 306 Ital.Pnr. Coys can be effected by transferring personnel to other units within 230 Division.
4. If this is not practicable will you please ensure that 304 and 306 Ital.Pnr. Coys. are disbanded within the next few days since the British personnel are most urgently required elsewhere and definite posting instructions are expected to be received at an early date.

It is stressed that the major problem here is disposal of the vast quantities of British stores held by these units and that nothing can be done until definite orders, together with disposal instructions for stores, reach 211 Sub Area through staff channels.

Apart from other reasons why these idle hospitals should be got rid of, they are occupying valuable agricultural land, use of which could have been justified only on operational grounds when they were set up on April.

I would appreciate it, therefore if you could administer a prod or two to A.F.H.Q.

2. 521 FIELD HOSP.

This unit located at FRASSINETO (south of AREZZO) is serving no purpose whatsoever, and it is hard to see where else it could be employed in the Div area. If therefore it is not required elsewhere, its disbandment would be advisable.

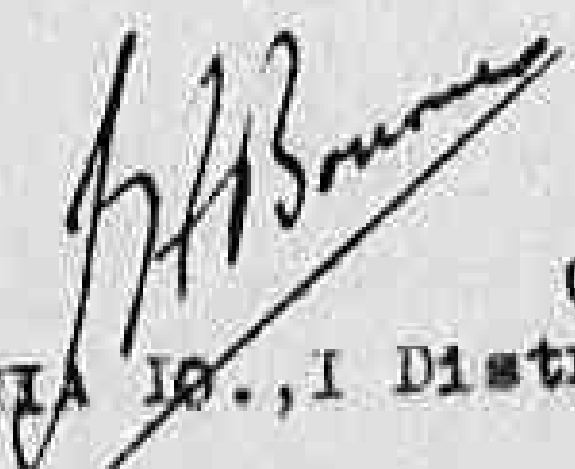
