2. Secondly, within the near future, the Italian ^{Army} Military Tribunal of War, will be located in Macerata Province and since it is the duty of the Legal Officer to work in liaison with that court, Bert's knowledge of the Italian Army Law, will be of invaluable assistance to proper liaison work.

1. It has been called to my attention, that Ernest Bert, Court Interpreter in the Legal Office, A.M.G. Ancona, has been called to duty as an Officer in the Italian Army. 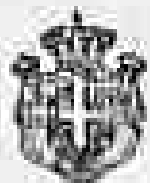

They anticipate it will not be before the end of 2 months (.). In reply your paragraph 3, reference signal, personnel on arrival will be under command of British Headquarters; Postal address unknown at present; probably length of stay indefinite; grades of officers should not be above that of Major, and grade of Captain or Lieutenant considered preferable (.).
