1. Will you please signal all Regional Commissariato to instruct all Italian Depot Commanders to render a return of actual physical stock held in each depot as at the close of business on the evening of 15 October 1944.
2. Returns to be forwarded to Regional Commissariato as soon as possible after the 15 October 1944, where they will be checked, and signalled by the MMIA LO concerned direct to this Headquarters by not later than 20 October 1944.
3. These figures will form the opening stocks under the new accounting policy recently explained to Col. FIBICARO, and the new system of stock operations which becomes effective 16 Oct, 1944.
4. All stock state returns will be shown in pounds, by commodities, and will be consolidated for each Sector by the MMIA LOs before forwarding to this Headquarters.
5. Strict accuracy and compliance with these instructions is essential.
