SUBJECT: For Information as Regards the Animal Situation in:
Sardinia (II).

TO : Colonel F. L. Simmons.

1. As mentioned in part 5 of my report of 8 July 1944, Major Cremonesi and Lieut Mc Crea have made a complete inspection and classification of all Italian Army animals in Sardinia. This was done during 5 July-22 July. Further animals are rationed by the Italian Army, working for services such as: Ospitali di Campo, Finanza, Marina, Dicot, Centro Results Notizias, and various Saggasini Commissariats. These animals are widely scattered and their number is estimated at 50-100.

2. In each case the H.Q. of the Division or unit was visited first to ascertain the location of the animals. In some cases this information was exact, in others the individual visits showed a wide divergence in numbers and location of animals. In many cases owing to the departure of the units, there is great dislocation of the animals and variations in the amount of work they are doing. For example horses at Maddalena are hard worked; at Tempio there is a surplus.

Owing to this scattering of the animals there is a lack of veterinary attention and three (3) animals were found to be moribund from Equine Prostration at the time of our visits - a horse and a mule at Tiesi and a horse at Paulau. These animals were receiving no attention and if Major Cremonesi had not given orders for their immediate destruction, they would have been left on the ground to die. A large number of the horses destroyed were on account of this disease (Appendix 3). Many other latent cases were seen and at this season more cases will occur.

4. During the inspection the criteria of rejection was (1) over 15 years old and (11) unsuitable for active service (details in appendix 3). Of the 772 animals inspected 84% (650) were considered suitable for retention by the Italian Army; 13% (99) were rejected but suitable for farm work and 3% (23) were destroyed.

5. In the case of animals to be destroyed Major Cremonesi gave orders for their immediate destruction and the meat, if suitable, to be salvaged and given to soldiers or the civilian population. In several cases units were revisited on our return journey and it was found that the orders had been carried out.

In the case of animals found suitable only for farm work, orders were given for their transit to Cristano where they will form Group III (Appendix 2, column C). Their location at time of inspection is shown in Appendix 3.

When all the animals are assembled at Cristano, there will be a total of 320 horses and 130 mules for distribution. On 22 July 225 horses and 130 mules were present at Cristano.

6. Since the last shipment of mules on 24 June further mules have been discovered at: Cagliari (one - accepted), Poetto (one - reject), Tulesi (one - dead), Ozieri (one - accepted), Osello (one - accepted), Olbia (six - rejects), Sassari (five - rejects), a total of 16.

7. There are 650 sound horses on the island with the Italian Army, this includes the 120 saddle horses. No attempt was made to classify the horses into draught and saddle groups as with few exceptions they are all being used as draught animals. Of these 650 horses 70% are in good condition and less than 10 years old. The remainder still show varying degrees of emaciation but should recover.

8. During the tour a Stallion Depot at Ozieri was visited. It is run by the Ministry of Agriculture but has Army Personnel, a Colonel being in charge. Fifty (50) stallions were inspected, there being a further 50 at outstations in the island. The breeds represented are English thoroughbreds, Arab, Sardinian, and crosses. The depot is well organized and the animals are in excellent condition.

9. Twelve (12) saddle horses have been handed over on loan to the 7th AAA from the 40 riding horses at S. Bartolomeo. Major Freund of the 7th AAA and Major Guittierrez of the Italian Army are in charge of the riding school.

10. Throughout this work Major G. Cremonesi of the Italian Army Veterinary Service has been cooperative and helpful to the highest degree.

Conclusions

40 saddle horses and 16 mules are the final figures for animals awaiting shipment.

320 saddle horses and 136 mules will be the number of animals available for distribution to farmers.

60 horses remain on the ration strength of the Italian Army. A further 50-100 are distributed throughout the island and are rationed from Italian Army warehouses.

SUBJECT: Final Disposition Unserviceable Italian Army Animals

TO : Commanding General, Army Sub Commission, ACC, A.P.O. 394, U.S. Army

1. Request that High Commissioner for Sardinia be advised by the Ministry of War that the disposition of unserviceable Italian Army animals is to proceed as planned both with reference to handing over those qualified for work to farmers and to destroying the remainder. At present he is hesitating due to the receipt of a letter from the Inspector General, Egidio del Punta (inclosure 2). The High Commissioner, General, Pietro Pina, is disposed to cooperate with our Allied Regional Commissioner, Brigadier Carr, but naturally is reluctant to proceed until the effects of above-mentioned letter are removed. For your information copies of various directives contributing to the present situation are inclosed herewith. It should be noted that all estimates as to numbers of animals of various classifications were based upon the report of Commanding General, Comando Militare della Sardegna of 4 May 1944 (inclosure 3) and that deviations from original estimates have been the result of the disagreement of Allied veterinary officers as to age and serviceability of animals or to erroneous count upon which Comando Militare della Sardegna's report of 4 May was based. In addition, the outline of plan agreed upon by Allied Armies in Italy, G-1 (Lieut Col McLean) and in process of being effected is submitted below.

a. Commanding General, Comando Militare della Sardegna, advised that all mules, all saddle horses except one hundred and twenty (120), and all draft horses over fifteen (15) years of age or otherwise unserviceable were to be assembled and placed at the disposition of the Allies.

b. In order to insure proper disposition of unserviceable animals not to be destroyed the Allied Regional Commissioner was requested to arrange for the handing over to farmers of such animals by whatever means he should devise. Brigadier Carr chose to execute the plan through the civilian organization of the High Commissioner for Sardinia, General Pina. The animals to be destroyed are in process of destruction at the

clinics or units where they are found by our veterinary officer who acts in company with a veterinary officer of Comando Militare della Sardegna. The animals to be handed over to farmers are being assembled at Cristano because of the central location of this town.

2. It is important to proceed without further delay as farmers should have use of the animals at once if they are to be required to care for them during the ensuing winter which requirement is a clause in the agreement entered into at time of transfer.

3. As soon as Comando Militare della Sardegna is in receipt of directive from S.M.R.E., Brigadier Carr is prepared to proceed with the transfer which will continue until all over-age animals have been disposed of.

SUBJECT: Horse and Mule Situation
TO : Regional Commissioner, ACC, Region 6

1. In confirmation of our conference on 5 July 1944.
2. Since 83 saddle horses, 94 draught horses and 122 mules have now arrived at Oristano, it is considered that this is a sufficiently large group to dispose of at once. A further group will be assembled toward the end of July.
3. The name of the Commanding Officer of the Gruppo Squadroni Cavalleria di Sardegna at Oristano, in whose barracks the animals are is Maggiore CALEDON, Enrico.
4. It is agreed that the farmers who receive the animals should sign a certificate to the effect that they will keep the animal/s for a period of at least one year, and will not slaughter them unless with the permission of a local (civil) authority to be nominated by you.
5. Copies of these certificates to be retained by you and by the High Commissioner, with information copies to Army Sub Commission.
6. List showing description of each animal (number and age) is inclosed herewith.

TO : Commanding General, Allied Armies in Italy

1. The following is a summary of the situation regarding horses and mules in Sardinia, and is forwarded in confirmation of my cable No. 143 dated 5 July 1944.

2. Shipped to mainland on 27 June 1944

3. This left a balance of 76 riding horses at Cagliari on 27 June; these were the worst animals of those originally selected, and were only accepted when an attempt was being made to reach the original total of 285 for shipment.

Of these 76, 57 are considered suitable for shipment. Of the remaining 19,

15 are suitable as light draught horses and will be handed over to the Italian Army.
22 are unsuited saddle horses and will be sent for disposal to farmers
1 is gravely ill
1 dead

4. A subsequent round up has produced 1 more saddle horse and 14 mules, making the total available for shipment as at today's date.

From among the unserviceable mules, the veterinary officers from your headquarters selected 152 mules which they consider to be serviceable. These 152 animals are assembled at S. Bartolomeo.

It is therefore requested whether or not the above mentioned mules which are surplus over the original request are also to be sent to the mainland.

In case of an affirmative answer it follows that the number of animals to be destroyed or given to the farmers will not be 340 but instead 176 (152 considered serviceable plus 12 dead).

You are also informed that 27 horses and 6 mules which are being hospitalized will not be among the animals that are to be assembled at Oristano until a later date.

Tomorrow, 24 June, 1944 this headquarters will inform you as to the number of mules assembled at Oristano.

1. Reference your 42/Vet/Para 1/F/Sgt-Webb and Lt. M. R. McCree reported to Colonel Simmons on June 2nd.
2. The duties allocated consist of classifying Italian Army mules and riding horses, and general advice regarding their feeding and management while awaiting shipment.
3. 485 mules have been selected of which 60% are in good condition. The remainder are suffering from varying degrees of excoriation and are on a supplementary diet.
4. 230 horses have been selected of which 40% are in good condition. The remainder are receiving a supplementary diet.
5. Further arrivals of horses and mules are expected.
6. A shipment of potatoes, ex N. Africa has been inspected and the potatoes found fit for human consumption.

In consequence of a telephone message from Captain F.E. Stencil A.G.S., on 28 May 44 I proceeded to Oristano on 29 May and met he and Lieut. R.I. Miller, P.B.S. Remounts at the barracks of the Gruppo Cavalleria de Sardegna.

Capt. Stencil acquainted me with the contents of H.C., A.A.I. letter IO46/I/QI of 23 May 44 and suggested that in addition to acting as casting authority I should assist in the requisitioning of horses and mules held by the Italian army in Sardinia.

At the Cavalry Barracks, Oristano and the Artillery Barracks San Bartolomeo a total of 191 horses were examined and 138 selected for requisitioning. Horses were rejected for the following reasons: lameness, extreme debility; old age, bad conformation and chronic wounds.

40% of the horses selected are in good condition, 30% in fair condition and 30% in poor condition. The majority of the horses are of good stamp and quality and there is a number of good type dual purpose cobs amongst them. With good feeding and management these horses should make up into useful remounts.

On 30 May 44 177 mules were inspected at the Artillery Barracks San Bartolomeo. 30% were in good condition and the remainder in fair to poor condition.

As these mules had been returned during the last few days from units where they had been on scanty rations I recommended that 175 should be requisitioned provisionally and put on full scale rations. 1. Reference is made to letter this office, subject Additional Horses and Mules, dated 15 May, attention paragraph 1 (a), (b), (c).
2. The number of mules required remains at six hundred and twelve (612) which according to your report of 4 May is the entire number of serviceable mules under fifteen (15) years of age.
3. The number of saddle horses now required is two hundred and thirty five (235) which leaves a total of one hundred and seventy (170) to be left with the Italian Army.
4. It has been decided that all draught horses will remain in Sardinia.
5. The total number of animals to be handed over to farmers or destroyed is now six hundred and seventy three (673).

TO : Commanding General, Italian Forces in Sardinia

1. In accordance with your estimate of 4 May 1944 and instructions contained in letter from Commanding General, Army Sub Commission, A. C. C. 7 May 1944, additional animals required are listed as follows:

- a Mules 618 This figure includes all mules remaining in Sardinia except 340 reported unserviceable.
- b Saddle Horses 406 This figure includes all saddle horses remaining in Sardinia except 126 reported unserviceable.
- c Draft Horses 600 This figure includes all draft horses remaining in Sardinia except 581 to be used by Comando Militare della Sardegna and 207 reported unserviceable.

2. It should be noted that no animals are to be retained for the Artillery of the 204 or 226 Divisions or the Grenadiers Group, which organizations are to be employed as Internal Security Divisions.

3. It should be noted further that the 300 animals reported in paragraph 2 of your estimate of 4 May 1944 must be obtained from the 581 draft horses remaining after subtracting 600 draft horses for shipment plus 219 animals to be selected from those reported as unsuitable for field service because of being over age, etc.

4. From the above, it is concluded that 454 animals, (mules, saddle horses and draft horses) will remain to be handed over to farmers or be destroyed.

1. In accordance with the provisions of letter, HQ A. A. I., 1046/1/Q1 dated 18 April 1944 and letter Army Sub Commission, A. C. C., 0/1/5 dated 25 April 1944, the requisitioning of all serviceable mules, all serviceable riding horses under fifteen years of age and five hundred (500) draft horses has been initiated with Comando Militare della Sardegna.

2. In a report rendered by the Commanding General, Comando Militare della Sardegna as of 1 May 1944, the data relative to numbers of animals in various categories, as indicated in the table below, was submitted:

The above data include three hundred and forty five (345) of the four hundred (400) saddle horses previously ordered requisitioned from Comando Militare della Sardegna by A. P. O. 9 February 1944 and three hundred and thirty nine (339) mules already allocated to Allies, held here awaiting shipment.

3. The actual availability of animals reported above is qualified in the report of the Commanding General, Italian Forces in Sardinia due to necessities for local use which he outlines as follows:

a. Requirement of animals in order to assure a minimum of operation of service for the units left on the island.

 Even conforming with the above minimum a shortage of (800 less 581) 219 animals will occur.

b. In case that the needs of the 100/22 horse-drawn groups of the 204th and 220th Division and of the Grenadiers Groups were taken into account, the needs would be as follows:

c. The 203rd and 205th Divisions have not been considered, since the two above Divisions will be disbanded after the formation of the battalions for the guard service and laborers.

CONCLUSION:

As has been said in the preceding paragraph, for our needs, we would require 120 saddle horses and 1,136 draft horses (800 + 336). If that were granted, the following animals could be released to the Allies:

1,244 Mules (including the 336 already released and awaiting embarkation)

336 Saddle Horses (including the 345 already released and awaiting embarkation)

Draft Horses None (there is already a shortage of 55 draft horses, on the basis of our requirements (1,136 less 1,081).

In the case that the sending of the 500 draft horses to the Middle-East be found necessary, it will be necessary that they should be replaced by an equal number of mules, which would then be reduced to 744 (1,244 less 500)."

4. With reference to paragraph 4, letter Army Sub Commission referred to above, the following list includes the minimum personnel necessary to place in effect the requisitioning, classification, feeding, and shipment of animals required.

H.Q., A.A.I. (Adm Ech)

1. Reference your 1046/1/Q1 of 3 April 44.

Proposals for Requisitioning and Disposal of Animals

- (a) It is noted and agreed that you have requested MMIA to requisition the remaining 587 mules and 1068 riding horses, and a proportion, not specified, of draught horses.
- (b) It is also noted and agreed that you have requested MMIA to destroy any animals which are unserviceable either through age or emaciation.

2. United States Army Pack Troop.

Assuming that the 587 mules referred to in para 1 above can be made available, 400 are required for the formation of a United States Army Pack Troop, including 10% replacements for three months, and should be earmarked for this purpose.

3. Animals now requisitioned.

- (a) According to information available at this H.Q., the number of mules awaiting movement should be 528 and not the figure shown in your letter. There are in addition, approx 400 horses also requisitioned.
- (b) According to information available, the animals mentioned in para 3 (a) above are due to be moved from SARDINIA to ITALY about 20 April 1944.

4. Forage.

- (a) Your proposal that all Italian Army animals should receive a subsistence ration of forage (two-thirds Field Scale) is agreed and provision arrangements are in hand. It is also agreed that as soon as additional animals are requisitioned for Allied use they should be put on full Field Scale Ration.

- (b) Assuming that movements of animals already requisitioned are carried out as indicated in para 3(b) above, it is estimated that there should be available in SARDINIA approx 30 days forage for 1800 animals at two-thirds scales, with effect from 20 April 1944.

(c) In order that the necessary provisioning arrangements can be made, it is requested that you will notify earliest possible:-

(1) The actual numbers of animals by types that it is proposed to requisition, and the date of requisitioning.

(1i) The number of Italian Army animals that will require to be maintained on the two-thirds Field Scale.

(d) Separate instructions are being issued in regard to the movement of additional supplies of forage into SARDINIA.

It is suggested that the date for the maintenance of animals not at present requisitioned should be so fixed that there is no possibility of the 928 animals already requisitioned (para 3) running short of forage if for any unforeseen reason the proposed movement programme is delayed.

5. Continued Maintenance of Animals to be Requisitioned.

It is understood facilities for grazing animals exist in ITALY. Will you please forward your recommendations with regard to the possibility of having the animals that are to be requisitioned moved to and maintained in ITALY.

6. Light Draught Animals for MIDEAST.

M.E. have requested the release of up to a maximum of 600 light draught animals to be moved to M.E.

A separate cable is being despatched regarding the possibility of shipping these animals.

REPORT ON A SURVEY OF MULES AND HORSES IN SARDINIA.

copy for your files

1. In accordance with instructions received from (Maint) AFHQ, I arrived in Cagliari Sardinia on March 13th 1944 for the purpose of making a survey of Military Mules and Horses on the Island.
I reported my arrival and purpose to representatives of the Staff of the Commanding General Allied Garrison.

2. I interviewed the Italian Military Commander of Sardinia and obtained from him the following particulars of Military Mules and Horses on the Island:-

(a) Requisitioned and awaiting shipment to Italy for use of the Allied Armies:-

Mules..... 451.
Horses (Riders)..... 402.

(b) With Italian Organic Units and required for their fighting Formations:-

Mules..... 587.
Horses (Riders)..... 1068.
Horses (Draught)..... 1751.
Total. 3406.

Note.- These figures were stated to be correct up to February 29th 1944. Many deaths have occurred since that date but no details were available.
According to the Italian Military Authorities all unserviceable animals had previously been destroyed so that the above figures represent serviceable animals according to Italian standards.

3. Points raised by the Italians in regard to these animals were as follows:-

(a) The majority of the mules formed part of the equipment of the 150 Units on the Island and consequently they were opposed to any further requisition by the Allies if the Italian Garrison of Sardinia was to remain effective.

The Horse and Mule situation as a whole in Sardinia may be reviewed as follows:-

- (a) A large proportion of the Military Horses and Mules exist in small groups of from 1 to 20 animals. Such animals have maintained fair condition by making use of grazing and should continue to do so until the end of June.
- (b) Italian Animals held in large numbers such as those at Cagliari, Sedrai and Sassari are in a deplorable condition owing to lack of forage. Many are dying of starvation and will continue to do so unless forage is supplied.

7. Availability of forage from local resources..... Nil.

8. Civilian owned Mules and Horses.
 Sardinia uses mostly Oxen and Horses for draught purposes and the Mule population is comparatively small.

(c) Whether or not a decision is taken to requisition part or all of the remaining animals, all should be provided with a subsistence ration of forage (2/3 Field Scale) to prevent a very bad state of affairs becoming even more deplorable and valuable livestock dying of starvation.

10. On March 19th 1944 I arrived in Naples and reported as above to D.D.V. & R.S. at H.Q. Admin Bebelon, A.A.I. and returned to Algiers on March 20th 1944.

Definite information as to the number of above vehicles which can be put in good running order was unobtainable as the officer in charge of the vehicles, Lieut Tommasi, claims he has not yet had time to inspect them, his mobile repair unit having moved into the present location only about two weeks ago. The best estimates made appear in parenthesis in the above list. Lieut Tommasi claimed that no repair materials are on hand, the French having taken all repair materials on the island. The above vehicles have been earmarked for shipment to Sardinia. The claimed reason why these vehicles are so poor is that the French authorities after inspecting all of the Italian vehicles, selected the best for themselves.

In addition to the above vehicles, the Italians have under their control at present, and available for their use, but earmarked for transfer to the French, the following vehicles:

- Staff cars.....8

- Truck, heavy.....30

MEMORANDUM

SUBJECT: Inspection Tour

TO : Col. Simmons, ACCLFSC

March 8. Visited Gruppo Squadrone Cavalleggeri at CRISTANO with Lt. Miller, Vet. officer, to inspect 262 horses requested for use by the Allies. The horses were in good condition and were extremely well taken care of.

March 9. Went to Intendenza at OZIERI and received 200 halters and 250 chains needed to equip mules requested by Allies and concentrated at SAN BARTOLOMEO.

March 10. Conference with Major Cadeddu, C.O. of Gruppo Squadrone Cavalleggeri and Lt. Miller at CRISTANO concerning the possibility of his taking care of an additional 140 horses at his camp. This latter number represents balance of horses requested by Allies and still remaining on Sardinia. The advantages of such a plan would (1) Concentrate all horses requested by Allies in one place, (2) The feeding of the animals would thus be simplified. Major Cadeddu agreed to the added responsibilities and stated that he would make a list of all requirements and present them to me at Cagliari on March 12. He gave me as an initial basis, the following information: (1) Sheds available at TANCA SPINALEA, 7 km. East of CRISTANO, capable of covering 140 horses (2) A detail of 70 MM and 1 officer needed to administer the new camp.

March 11. On the basis of conference with Major Cadeddu, presented my case to Col. Harding, G-4. Col. Harding stated that sheds at TANCA SPINALEA could be ready for use by March 20. He told me to contact Lt. Monami at Italian Air Force Headquarters who would furnish men and materials required to set up the new camp.

March 12. Conference with Major Cadeddu, Lt. Monami, Capt. Maniscalco and Lt. Miller at Italian Headquarters. Capt. Maniscalco stated that he could send the necessary personnel and could effect the movement of horses requested for use by the Allies to TANCA

2.

SPINALBA by March 21-23. Accompanied Major Cadeddu, Lt. Wozani, Lt. Miller to TANCA SPINALBA to make a final survey of the sheds and pasture land available.

March 13. Accompanied Lt. Col. Rix, Veterinary and Remount Section, AFHQ, to SAN BARTOLOMEO to inspect mules which have not as yet been requested for use by the Allies. All of the animals inspected were in poor condition and were undernourished.

March 15. Accompanied Lt. Col. Rix and Lt. Miller to 552 Battalion at VILLASOR to inspect 8 horses, 2 of which had already been requested for use by the Allies. The animals were in a fair condition. They are being fed 3 pounds of oats and 1½ pounds of hay per day.

REPORT ON A SURVEY OF MULES AND HORSES IN SARDINIA

SECRET

1. In accordance with instructions received from Q(Vsint) AHFG, I arrived in Cagliari Sardinia on March 18th 1944 for the purpose of making a survey of Military Mules and Horses on the island.

I reported my arrival and purpose to representatives of the staff of the Commanding General Allied Garrison.

2. I interviewed the Italian Military Commander of Sardinia and obtained from him the following particulars of Military Mules and Horses on the Island:-

(a) Requisitioned and awaiting shipment to Italy for use of the Allied Armies:-

Mules.....451.
Horses (Riders)....402.

(b) With Italian Organic Units and required for their fighting Formations:-

Mules.....587
Horses (Riders).....1068

Note.-- These figures were stated to be correct up to February 20th 1944. Many deaths have occurred since that date but no details were available.

According to the Italian Military Authorities all unserviceable animals had previously been destroyed so that the above figures represent serviceable animals according to Italian standards.

3. Points raised by the Italians in regard to these animals were as follows:-

(a) The majority of the mules formed part of the equipment of the 150 Units on the Island and consequently they were opposed to any further requisition by the Allies if the Italian Garrison of Sardinia was to remain effective.

(b) Opposition to requisition was also offered in respect of Mules and Draught Horses required for Unit and General Garrison Transport duties.

Of the total of 587 Mules, 372 form part of the equipment of 3 Mountain Units and if use is to be made of them, no requisition of their Mules would be possible.

The balance of 215 constitute Unit Transport for 150 different Units or Sub Units.

I therefore consider that the 215 could be made available for Allied use and replaced by Draught Horses.

Difficulties of collection and replacement would be considerable and in any case could not be effected until the Draught Horses are in a condition to be moved.

4. As the animals were widely dispersed throughout Sardinia, it was only possible in the time available to inspect a representative sample.

Inspections of the following were carried out:-

(a) Requisitioned and awaiting shipment:-

Mules.....451.
Horses (Riders).....320.

Details of inspection as at appendix "A"

(b) Not requisitioned and with Italian Units:-

Mules.....1331.
Horses(L.D. & Riders)..179.

Details of inspections as at Appendix "B".

5. Grazing Facilities

The country as a whole is a sheep country and the grass is only suitable for the maintenance of sheep.

Where sheep have grazed there is little grass left for horses.

The country "dries up" towards the end of June and no grazing for Horses or Mules is available after that date.

6. The Horse and Mule situation as a whole in Sardinia may be reviewed as follows:-

(a) A large proportion of the Military Horses and Mules exist in small groups of from 1 to 20 animals.

Such animals have maintained fair condition by making use of grazing and should continue to do so until the end of June.

(b) Italian Animals held in large numbers such as those at Cagliari, Seirai and Sassari are in a deplorable condition owing to lack of forage.

Many are dying of starvation and will continue to do so unless forage is supplied.

7. Availability of forage from local resources.....NIL.

8. Civilian Owned Mules and Horses

Sardinia uses mostly Oxen and Horses for draught purposes and the Mule population is comparatively small.

The few seen were of good type and suitable for Military requirements.

Lt. Colonel Long, the British Co-Director of the Allied Local Resources Board Sardinia, has promised to obtain figures for the civilian owned Mules on the Island and will report in due course.

9. Recommendations.

(a) All animals requisitioned or earmarked for the Allied Forces should be concentrated and shipped to the mainland as soon as possible.

While so concentrated their maintenance should be supervised by a detachment of qualified Allied Personnel quartered in the camp.

At present 2 U.S. Veterinary Officers are in charge and I do not consider this adequate without a detachment of O.P. personnel living on the spot.

(b) All requisitioned animals should be branded, numbered and listed.

(c) Whether or not a decision is taken to requisition part or all of the remaining animals, all should be provided with a subsistence ration of forage (2/3 Field Scale) to prevent a very bad state of affairs becoming even more deplorable and valuable livestock dying of starvation.

10. On March 16th 1944 I arrived in Naples and reported as above to D.D.V. & R.S. at H. Q. Ada. Echelon, A.A.I. and returned to Algiers on March 20, 1944

The Italian Veterinary Officer gave the impression of being keen and capable and stated that no cases of Epithelial Lymphangitis had occurred in the Squadron for 12 months.

Shoeing:- All horses were shod all round.

Clipping:- All were clipped, except those being treated for Mange.

Equipment. Italian head collars and head ropes in good repair.

General:- These animals were well maintained and of quite good type, and will improve in condition provided that the same scale of forage can continue to be supplied.

The horses will be grazed as soon as they are fit enough to be ridden the considerable distance to the grass area.

(11) NUXIS 4 miles from CRISTANO.

A farm in course of preparation for the reception of 120 riding horses was inspected.

It is adequate in every respect and surrounded with sheep pasture.

The horses had not yet been collected and were scattered around the country, so no inspection of these was made. When concentrated in the farm, the animals will be maintained by a detachment of Gruppo Squadroni Cav. Sardegna.

(11) SAN BARTELOMEO, CAGLIARI.

20 Riding Horses. Maintained by the same Italian personnel as the Mules in the same location.

Condition:- All poor, 2 emaciated.

Near the various railway stations of the Island there are still centralised the echelons of mules recently assigned to your Command.

The improvised bivouacs and the reduced forage-rations in distribution, considering the very limited availability, it is advisable to transfer them out of the Island, this Command not being in condition to substitute the losses, already in great number, caused by death or by being taken into the infirmary.

We will be grateful to your Headquarters if the operations of embarkation will be hastened.
