5.- Owing to the remote location of their messes, also the necessity of close contact with NCOs of this Office, it is considered impractical for them to return to their billets for their meals, as there is no transportation available.

6.- Various U.S. Army Units in the Sassari District have voiced their willingness to feed either of these men at their regular enlisted men's mess, providing authorization is granted.

7.- Provision has been made for one of these men to billet at this Office, and the other at the U.S. Army NCOs' quarters, as it is necessary for them to be available on an average of 16 (sixteen) hrs daily.

SUBJECT: Request to Draw Ration for Yugo-Slav Soldiers.

TO : G-4, Headquarters Allied Garrison of Sardinia, APO 650, U.S. Army.

1. There are attached to this unit, the 1972nd Quartermaster Company Trk. (AVN), fifteen (15) Yugo-Slav Soldiers. These men came to the organization on or about 12 December, 1943 and since the date have lived and rationed here in the company.

2. For some time we drew class "B" ration for all of these men but recently a communication from higher headquarters directed that this practice be stopped immediately. The order was complied with until 14 May, 1944 at which time we received a letter from your headquarters, subject, "Rationing of Italian Personnel Employed in U.S. Messes", authorizing an organization of 100 men to employ 5 helpers for the mess. At this time we began to draw class "B" ration for only the five men we employed for labor in the kitchen.

3. However, in addition to the five men mentioned above, the unit employs ten (10) Yugo-Slav soldiers who do guard duty and other labor details other than those of the kitchen. During the day light hours these men walk guard duty alone but at night they are accompanied by one of our men. They have been of great assistance in keeping a sanitary camp and also in ridding the area of any Italians, in civil or military, who otherwise would trespass. In handling these duties in the area these men have relieved approximately ten (10) of our drivers each day who otherwise would have been held in camp for the duties. Due to this fact we have always been able to operate to capacity sending ten trucks more on the road per day than would be possible under ordinary operating conditions.

4. It is requested that this unit be permitted to draw class "B" ration for these ten (10) additional men as it would be very inadvisable to feed five (5) a class "B" ration and then draw for the other ten (10) at the Italian Supply Depot. This would necessitate the running of two messes.

5. The closest Yugo-Slav mess is at the St. Bartholomew Barracks in Cagliari and it would be rather impractical to take these men on a six mile trip each way, three times a day for ration. In view of the fact that this extra help has done and is still doing so much to enable us to run an efficient trucking company it is the hope of the undersigned that the requested permission will be granted.

1. Due to the shortages of American personnel for the operation of this Depot, it has been necessary to secure the services of ten (10) Italian Military personnel from the 361st Gruppo da Lavori Artiglieria Corpo di Armata. These soldiers are used on a seven-day-per-week basis, in the four classes of QM supply handled by this organization, and have become, over a period of time, at least semi-skilled in almost every phase of the Depot operation. On the average, they work 12 hours per day, but have always exhibited a willingness to work even longer, if the occasion demands it (as it frequently does).

2. Both because of the distance involved between this Depot and the camp of the 361st - and there is no Italian mess closer to this Depot than that of the 361st - and because of the difference in hours of messing between the Italian and the American armies, it is impossible to have these men return to their organization for messing, since their services are frequently required at mealtime. But, even if it were possible to mess these soldiers with their own group - as it is not - it is felt that maximum effort and cooperation would be secured from these men, were they required to work long hours with American rations, and then be "kicked out" at meal time, to be inadequately fed through Italian sources. At present, these soldiers are subsisting solely on unwanted leftovers from this platoon's mess which is at best an inadequate compensation for the really valuable services they perform.
