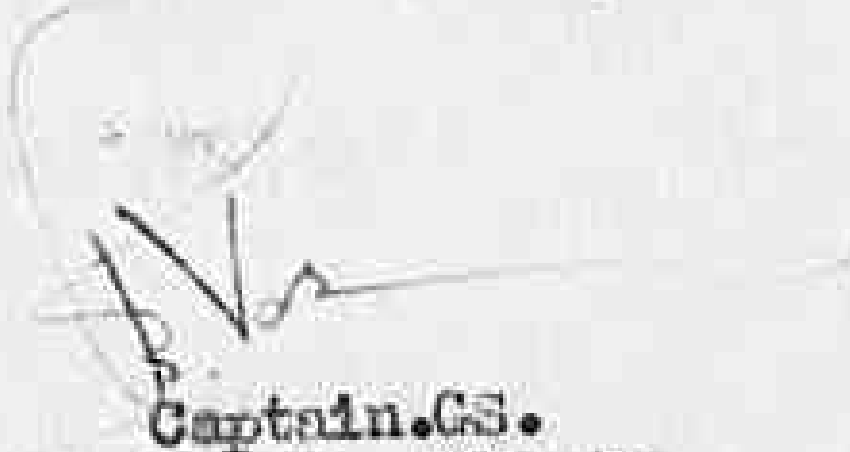

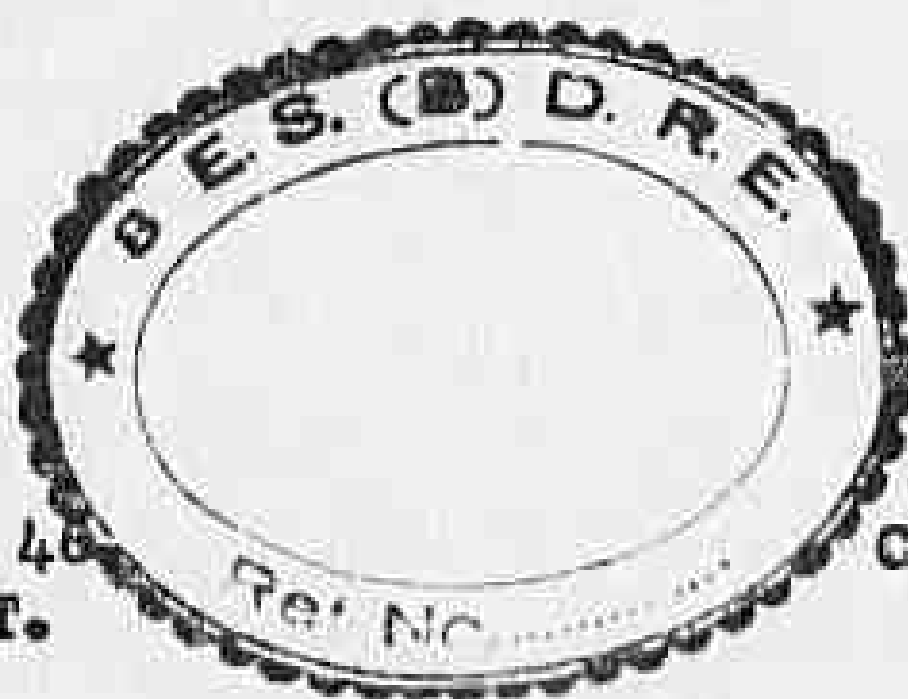

To the Civilian Practitioner.

(a) When a soldier is sick at the expiration of his leave and is unable to report in person to the nearest Military Medical Unit, he should be guided, in the action he takes, solely by the instructions on this pass.

(b) If fit to travel he should be instructed to return to his Unit and report sick to his Medical Officer.

If unfit, he should be furnished with a Certificate to that effect to be forwarded to his Commanding Officer, and at the same time be instructed to notify the nearest Military Medical Establishment.

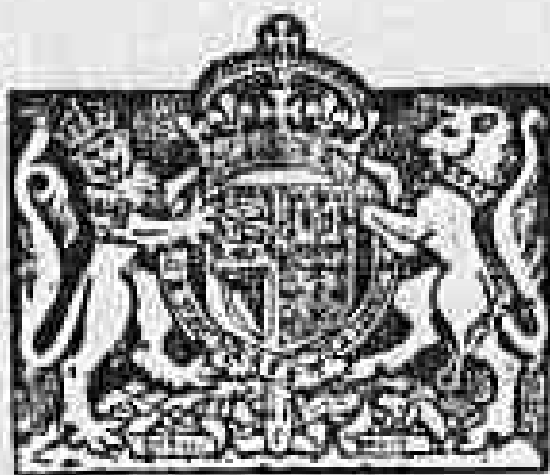
(c) To obtain payment for attendance on a soldier, a Civilian Medical or Dental Practitioner should satisfy himself that the above instructions have been carried out. He should submit his claim on Army Form 1007 (the scale of fees allowed are set out on the back of the form) which may be obtained from the local National Health Insurance Committee, and when completed should be forwarded to the A.D.M.S. of the Army, in which the soldier is temporarily residing for payment.

The Dental Practitioner will be paid only for strictly emergency treatment, and at the rates admissible under the National Health Insurance Act (Dental Benefit Regulations).
