Distribution 'E' British

1. Next-of-Kin may visit personnel in GHQ only at the direct request of the Medical Authority who must be satisfied that the patient is: -

- (a) On the Dangerously Ill List and likely to live long enough for the next-of-kin to reach the hospital.
- (b) Likely to benefit from the visit.
- (c) Unlikely to be evacuated before the visit can be made.

2. One relative only may visit.

3. Pending receipt of detailed instructions from the War Office the following procedure will be adopted in all cases.

4. When officers commanding hospitals consider that next-of-kin should be called forward they will notify number, rank, name, regiment and diagnosis of patient to GHQ 2nd Echelon.

5. GHQ 2nd Echelon will signal Record Office or Casualty Branch to whom casualties are normally reported (copy to the War Office AUSA(M)), requesting visit by the next-of-kin and giving details of casualty and number and location of the hospital.

6. The codeword "DILFOR" will precede all signals and correspondence relating to this scheme.

7. This Headquarters will be responsible for reception, accommodation,

3. Pending receipt of details, following procedure will be adopted in all cases.

4. When officers commanding hospitals consider that next-of-kin should be called forward they will notify number, rank, name, regiment and diagnosis of patient to GHQ 2nd Echelon.

5. GHQ 2nd Echelon will signal Record Office or Casualty Branch to whom casualties are normally reported (copy to the War Office AUSA (A)), requesting visit by the next-of-kin and giving details of casualty and number and location of the hospital.

6. The codeword "DILTOR" will precede all signals and correspondence relating to this scheme.

7. This Headquarters will be responsible for reception, accommodation, subsistence, onward routing (if required) and arrangements for return to UK of the next-of-kin.

8. All necessary costs of transport, rations and accommodation are chargeable to Public Funds. 4715

9. Visits will normally be for four days, subject to extension to a total of seven days. Such extension may be authorised by Officers Commanding hospitals. This HQ will be notified of all cases where extensions are granted in order that the necessary arrangements for delay of return passage may be arranged.

10. Return passage will be via Medloc 'C': authority, War Office cable AUSA/9992 dated 30 July 46. Return air passage will only be authorised in exceptional cases.

11. GHQ 2nd Echelon are responsible only for the despatch of the original signal to the War Office requesting the visit of the next-of-kin. All matters subsequently arising on this scheme will be referred to this HQ.

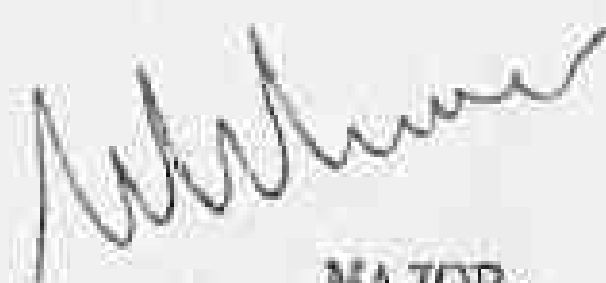

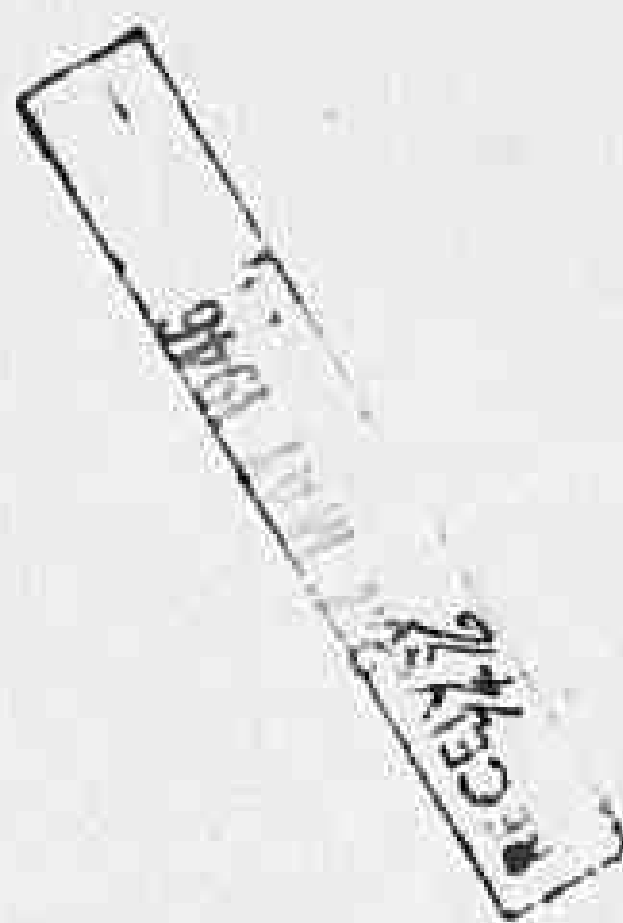

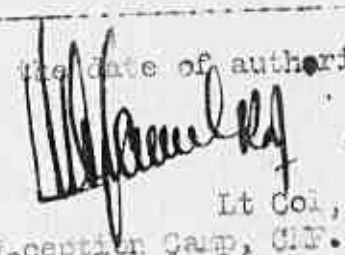
