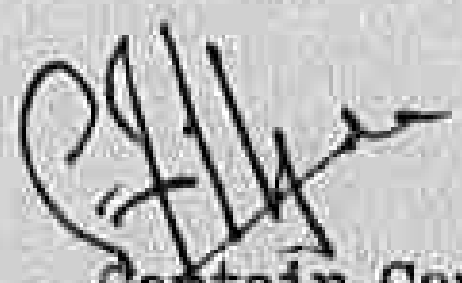

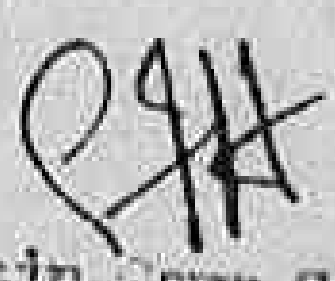

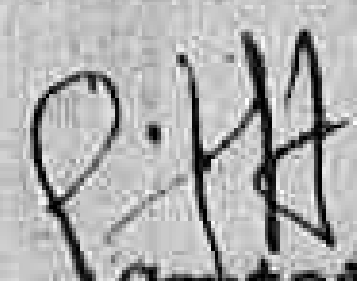

Persons leaving EGYPT may carry with them not more than LE 20 for each individual or the equivalent of this sum in stocks, Bank Drafts etc., for larger sums an application should be made to the Ministry of Finance for a special permit.

PALESTINE, IRAC AND PERSIAN GULF.

Importation of Bank of England notes is prohibited: Any such notes imported by disembarking passengers will be confiscated.

ANGLO EGYPTIAN SUDAN.

All passengers entering the SUDAN will be asked to declare the amount and kind of currency securities etc., in their possession. Transit passengers may not without permission take out a greater sum than imported. In addition, a resident leaving the country may not export more than LE 20 without permission.

USEFUL NOTES.

CANCELLATIONS.

In the event of cancellation, This Movement Order must be returned immediately to Gov. C. (C.C. IEP) or (Duty Officer Mov and In out of office hours) who should be informed by telephone as soon as it is known that there is a likelihood of cancellation.

EXTRACT FROM G.O. 1462 - IDENTIFICATION OFFICERS.

In order that Identification Card can be issued to officers on arrival, G.S.C. Collecting Centres will arrange for all officers proceeding to U.K. or other Commands from S.E. to have in their possession three passport size photographs in uniform, one of which will be signed by the bearer and certified by the G.O. to be a true likeness.

Officers proceeding individually will make their own arrangements for obtaining the necessary photographs.

The photographs, which should not be less than 2 1/2 in. by 1 3/4 in should show the head and shoulder of the bearer. Headress, naturals or collar badges will not be worn.

Baggage allowances differ considerably on various services. You should ensure therefore, that the weight of your baggage does not exceed the minimum allowance which may be allotted at any stage of your journey.

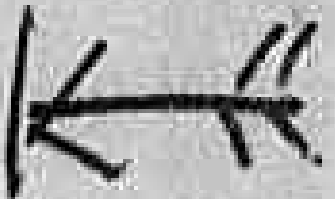

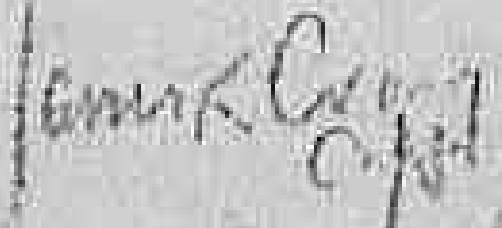
