Cine Citta	- 2 " (D.P.R.S.C.)
Cremona Camp	- 2 " ("K" Platoon)
Forli Hospital	- 2 " ("K" Platoon)

2. Your co-operation in permitting us to retain the above ambulances until replacements could be effected, is very much appreciated.

1. The Direzione di Sanita Italian War Ministry, apart from active operations, do not interest themselves in the dispositions of the Ambulance Cars of 1 M.A.C., which unit is regarded as being a responsibility of the Transportation Dept.
2. No objection will be raised by them therefore to transference of the section with Cremona to control of DP & HSC.
3. It should be noted that cars of 1 M.A.C. are <sup>also</sup> on loan to Dep. di Prigionieri di Guerra, Italian War Ministry.

2. As CREMONA Div have no objection to the whole of the ambulance pl assigned to them being withdrawn, and as Maj STEWART, the local rep of the Displaced Persons Sub Comm is desirous in view of his commitments to have this additional pl under his op control, it is submitted that this be put into effect.
3. To put the whole unit under AC op control would solve many of the problems which arise from its present position, serving several masters.
