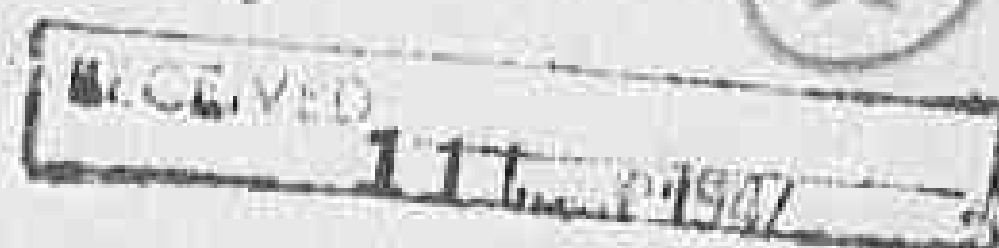

3. I have personally known of cases where a purchaser has been allowed to work by day and night on the building up of his wreck, only to have it taken from him the moment the last spare part was inserted, and the vehicle would go.

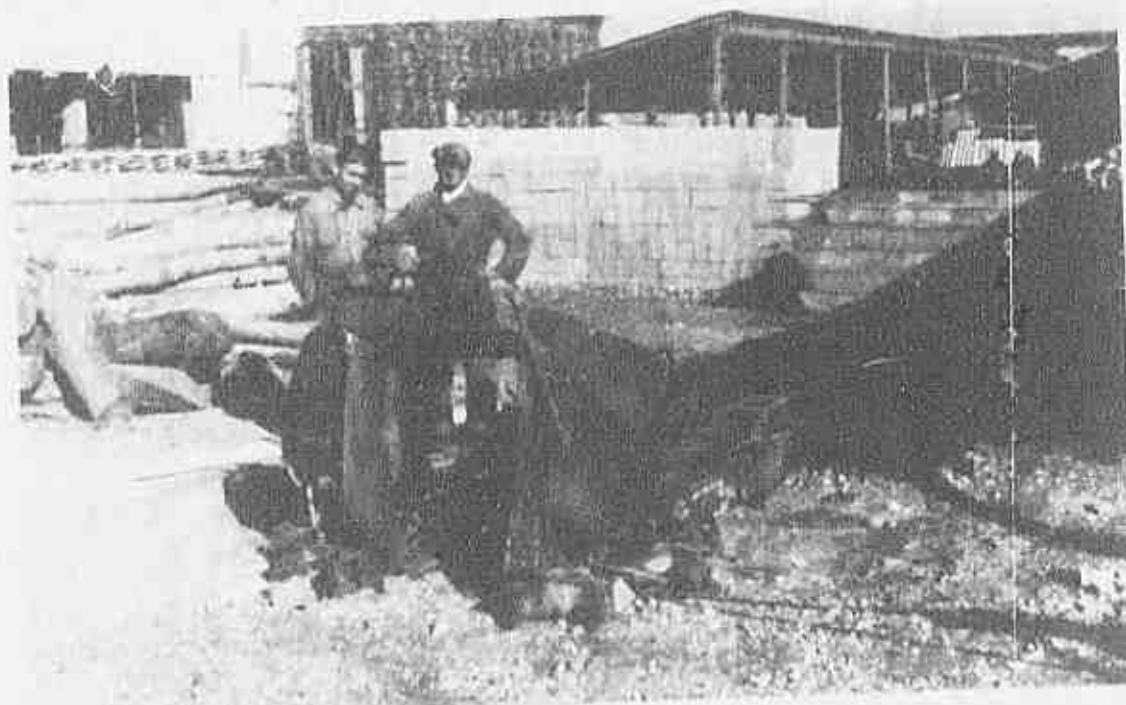

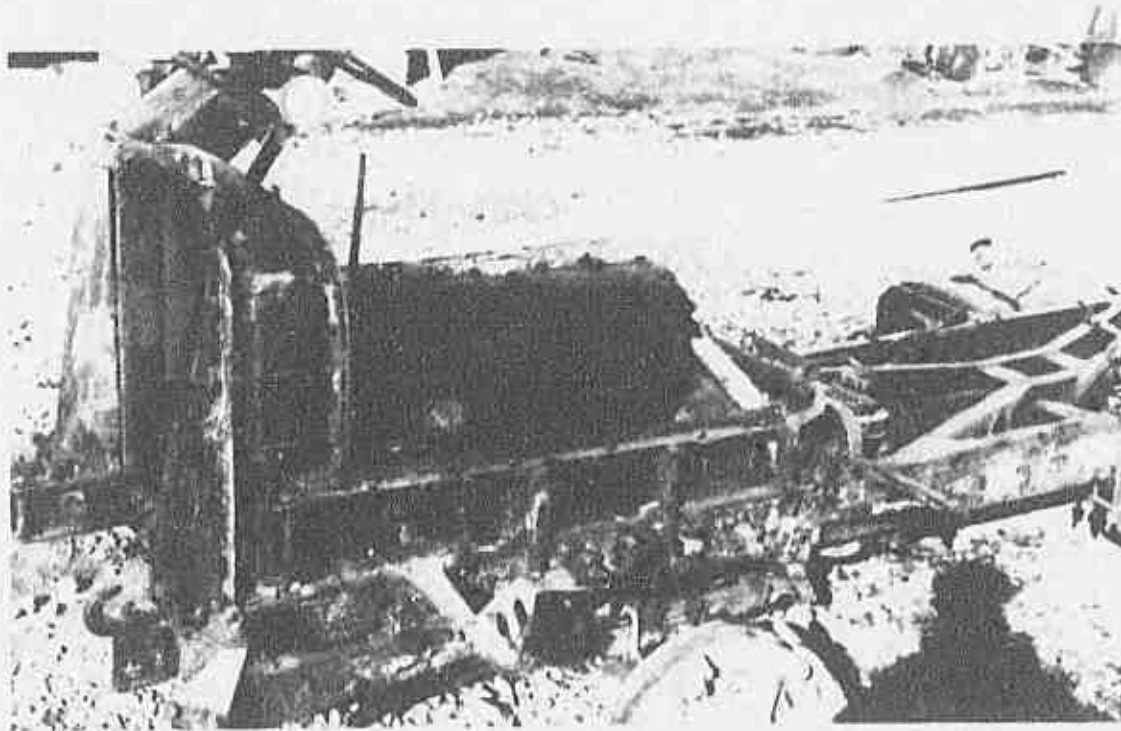

1. For a few months there has been some difficulty between 5 Territorial Command and AMG, Udine, concerning the collection from civilians, vehicles which were certified Italian Army property on 8 Sep 45.

2. Under Ministry of War directives 11800 U.R.M. and 200/2 D.A. of 28 Feb 46, these are now liable to recovery by the Italian Army, but AMG will not permit such collection in Udine Province, and the following paragraph from a letter of AMG Udine, defines this policy:-

" 2. All ex-enemy vehicles, assigned in Udine Province, are covered by an AMG agreement and, furthermore a temporary transfer document, entitling present holder to continue to operate vehicle, has been issued by this office for all a.m. vehicles. Lists of these vehicles have been sent to AG/CHM/Sub-Commission since 20 Dec 45 including all assigned vehicles declared before 14 Oct 45. "

3. At the request of AMG, Udine Province, the situation has been explained to the Director of Repairs, 5 Territorial Command on several occasions, but as he is acting on the Ministry of War instructions, no action has so far been taken and considerable friction is being created on this account.

4. As this problem continues to crop up it is desirable that the situation should be clarified and the Ministry of War requested to pass on appropriate instructions to 5 Territorial Command.

5. It is apparent that these vehicles will ultimately revert to the Italian Army and the anxiety of the Territorial Command to obtain possession at the earliest possible moment is quite understandable. In the meantime however, it would seem that the AMG instructions on this point are quite definite, under references Land Forces Sub Comm., M.M.I.A. letter Q.031 of 20 Nov 45, and
