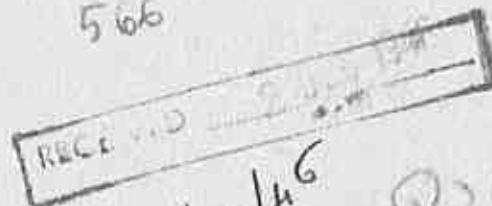

- (d) The question of obtaining credit for E.F.I. supplies is still under consideration and the decision will be notified as soon as received.

Accounting

(e) When necessary you will submit vouchers etc as required by the Area/Sub Area HQ concerned in connection with supplies and services rendered other than by the Italian Army.

(f) You will submit vouchers to this HQ for all supplies and services rendered by the Italian Army since 1 July 46.

A proforma should be used similar to that introduced for transport repairs (ie Form I/R. See Q. 204. of 26 Aug 46)

4. You are required to notify this HQ not later than 30 Sept 46 any departure from normal administration already introduced affecting Pay, Medical, Supplies, etc.

A similar report will be submitted subsequently as and when necessary as also any difficulties which arise between you and your appropriate Area/Sub Area HQ.
