SUBJECT: Transit Camp at CASERMA CAVOUR Via Brunelleschi - Turin.

TO : Land Forces Sub Commission.

1. The Town Major Turin has authorized this H.Q. to take over CASERMA CAVOUR, Via Brunelleschi Turin as a Transit Camp for Allied Nationals subject to our obtaining your approval.

2. We have agreed to accommodate a small detachment of 20 Italian C.Rs. who are at present guarding the Caserma, plus small additional accommodation of any other personnel which may report at the Caserma.

3. Your assistance in giving confirmation to our use of this centre would be much appreciated and kindly inform 11 Railway Engineer Group Italian if you are in agreement.
