1. Reference your buck-slip of 5 Sept. 1945, subject as above.
2. Arms and ammunition are not released to individual civilian agencies from Army stocks. Allotments on a bulk basis and on repayment are made by the Ministry of War to the Ministry of the Interior from stocks of arms not in general use throughout the Army.
3. For your information, Public Safety Sub Commission, A.C. has requested a consolidated return from the Ministry of the Interior, showing the strength, present holdings and estimated requirements of civilian police agencies. The requirements of Florence Questura will undoubtedly be included in this return.

1. This Headquarters is in receipt of letter 05037 of 10 August 45 from the Turin Questura requesting authority to hand in 200 rifles of various types to the local Artillery Depot in exchange for 200 Carbines, Special Troop type.
2. Please inform the Turin Questura that allotments of Italian Army arms to Public Security Agencies are handled on a bulk basis and the present request must, therefore, be refused. In cases of emergency, however, the local MMIA officer may be consulted and can authorize temporary assignments when he deems advisable.
