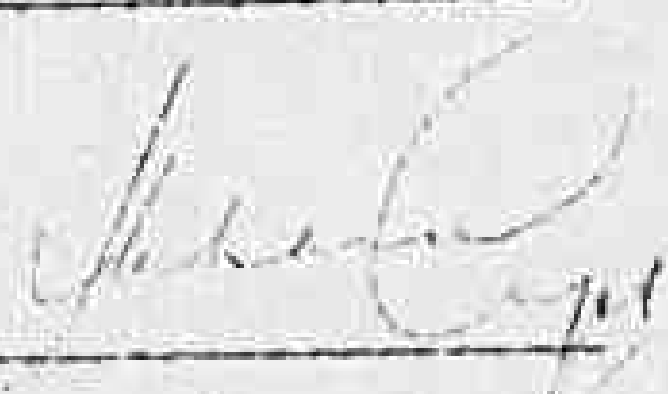

SUBJECT: Italian Military Bakeries.

Generally speaking we agree with MMIA's letter referred to above. Nevertheless this Ministry would advise the retention of some bakeries which are actually in operation, namely those at Bari, Naples, Palermo, Cagliari and Milan.

We are dealing in fact with bakeries established for some time (with the exception of the one in Milan), which produce a large amount of rations, using premises and plants belonging to the Military administration.

Up till now these military bakeries have never complained of any difficulties.

Since the military personnel authorized for the bakeries is almost exclusively made up by using civilian personnel, the actual authorized strength of 2 officers and 25 ORs could be reduced to 2 officers and 8 ORs.

Regarding the remaining areas (I Turin - II Genoa - IV Bolzano - V Udine - VI Bologna - VII Florence - VIII Rome), with the closing down of the relative military bakeries, certain personnel must be allocated - at least 1 officer and 4 ORs. These will be needed for:

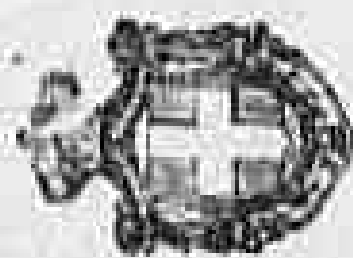

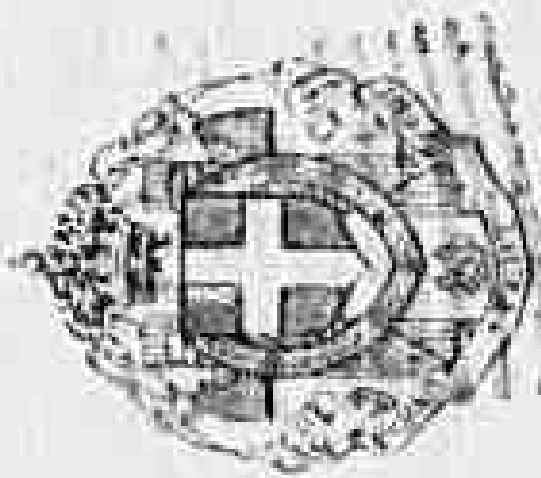
