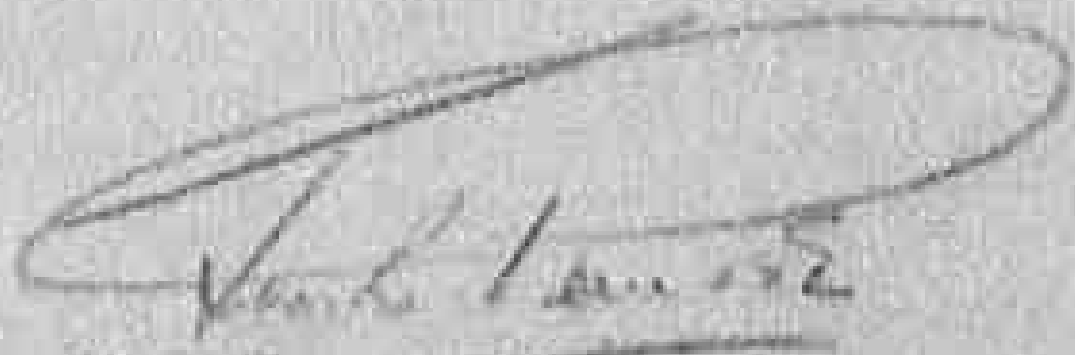

Dear, *to Col Perceval.*

The attachment of Ptes Mc Phee and Green to this Sector is now considered unnecessary. They were invaluable when we had heavy commitments on the docks and they did ~~stirling~~ work.

Now that almost the entire responsibility for the port work has been taken over by the Americans, these two men are not busy, and cannot be anything like fully employed.

Knowing that these men are surplus to MMIA W/E, and are only on attachment from G.R.T.D. I approached Major Smith on the subject of sending them back.

X Major Smith feels that by asking for their removal it will seem that he is trying to get rid of "two more English fellows" and establish an even greater preponderance of American personnel in the Sector.

Would you please, therefore consider the question and, if you consider it necessary instruct the Camp Commandant to terminate their attachment here.
