Sede." This is organized in a form of detachment separate from
the principal one under which EM are organized known as the
"9 Reparto di Sussistenza."

The bakery and all the warehouses were neat and orderly. The bakery works on a 24 hour basis and bakes approximately 11,000 rations of bread daily, plus hard tack for escort guards. The 2nd Frazione Deposito Speciale Viveri takes care of and distributes the flour and semolina assigned to it. The Direzione Commissariato is contracting privately for the eventual manufacture of maccaroni with the semolina, of which there is now a very large quantity.

Attached is an inventory of the material that is located in the warehouses.

The activity is efficiently operated, the material well guarded.

1. Report follows:

"Subject: 9th Reparto Sussistenza
Comdg. O.: Capt. Guarnieri

This is the unit under which are grouped all the E M working for the numerous Commissariato units plus those that go on guard duty on trains which totalled 213 on the day of the inspection and are included in the attached report under the heading "In servizio isolato."

The barracks, former armored car garages, were clean and orderly but also cold and uncomfortable to men who are coming off long train trips and rest only about 24 hours before returning to duty.

The discomforts of train guard duty was emphasized by the C.O. and hoped that I would see fit to recommend a more ample and varied ration than the existing one, consisting of hard tack, a can of Spam that serves for 3 days and two oranges or nuts and figs.

This unit also includes 78 men located at 3 Via Carriba who constitute a band. The band was also investigated and it was found to consist of Non-Coms of the regular Army. They have not played since 11 November, with the exception of a few who play with some of the Allied units. The attached report also shows that there are 70 men on leave, of these 28 are members of the band.

RECOMMENDATIONS: That the Non-Coms constituting the band be ordered to more active work or if it is felt that the band is good for morale purposes that it play in hospitals and camps.

From information received regarding the unit in question it appears that:-

- (1) The Bari military band had no further activities to go on with, from the 11th November last year, and was disbanded as an effective unit, as was also confirmed by MMIA in the letter of the 17 inst referred to above. The personnel were made available for other employment and attached to 9 Supply Unit Bari for billeting and since the said unit had heavy demands for the numerous duties of fatigues, guards and escorts.

The existence within the said Supply Unit of all the single elements that formerly formed the band, the strong comradeship and association of the troops of the band which matured during the long period of its activities, could have given the impression that the band still existed as a unit.

Orders have been given to the Military HQ of Bari Area Command confirming that the personnel of the disbanded band must be employed as supply personnel.

- (2) As reference is made to the high-percentage of personnel on leave from the 9 Supply Unit on the 9 January we would inform you that, in addition to the percentage allowed, 16 men were sent on leave in excess of quota on the New Year holiday in order to prevent any absence without leave, the others were on leave for serious family reasons.

Orders have been issued to call the attention of the O.C. of the unit to the strict observation of the orders in force in respect of leave.



Da notizie assunte in merito al reparto in oggetto risulta quanto appresso:

1° - Il complesso bandistico di Bari, come conferma anche codesta M.M.I.A. con il foglio in riferimento del 17 corrente, non ha più esercitato alcuna attività fino dall'11 novembre dello scorso anno ed è stato considerato disciolto come reparto organico. Il personale era stato dato disponibile per altro impiego ed aggregato al 9° Reparto Sussistenza di Bari per ragioni di accantonamento e dato che detto reparto aveva bisogno di uomini per far fronte ai numerosi servizi di manovalanza, di scorta e di guardia che gravavano su di esso.

La coesistenza nello stesso reparto di sussistenza di tutti i singoli elementi già facenti parte del complesso musicale, i vincoli di cameratismo tra i militari predetti maturati durante il precedente lungo periodo di attività del complesso stesso, possono avere dato l'impressione che l'esistenza della banda come reparto continui tuttora.

Sono state date disposizioni al Comando Militare Territoriale di Bari per confermare che il personale della disciolta banda musicale deve essere impiegato come personale di sussistenza.

2° - Per quanto si riferisce alla forte percentuale del personale in licenza, constatata presso il 9° Reparto Sussistenza alla data del 9 gennaio, è stato comunicato che oltre alla percentuale prescritta erano in licenza 16 militari inviati in soprannumero in occasione del Capo d'Anno allo scopo di evitare assenze arbitrarie; gli altri trovavansi in licenza per gravi motivi di famiglia.

E' stato disposto perchè il Comandante del reparto venga richiamato alla stretta osservanza delle norme in vigore in fatto di licenza.-

TRANSLATION.

Report of investigations ~~mentioned~~ into a theft of foodstuffs perpetrated in the military ration distribution depot of BARI the night from the 17 to the 18 Dec. 1944.

The 18 Jan. 1945, BARI.

BE IT KNOWN

That upon request from MMIA (letter ST/5317 of the 13 Jan. 1945), forwarded to the Commissariato Hq under the date of Jan. 17, a commission of the following officers convened today at the food ~~depot~~ depot:

Lt. Col., Agostino MEALE, QM
 Capt. Antonio BETTINARDI, QM
 both nominated by the comdg. Col., Commissariato as representatives of the BARI Commiss. Hq.
 Capt. Geo. C. GUTHRIE, representing the MMIA Det.

That as per inquiries into a/m theft suggested by MMIA in the above letter, the commission has ascertained the following:

- 1) The exact quantities of foodstuffs withdrawn by the thieves are:

- 2) Watch and security measures taken to prevent thefts at the ~~depot~~ depot consisted and consist in closing ~~and in the depot~~ tightly the entrance doors to the different huts of the ~~depot~~ depot ^{which} open into the internal courtyard of the depot and which are watched without interruption during the night by a guard who in case of suspect^{ed} or incidents is able to give the alarm to the military billeted in the dormitory of the depot.

In the interior no particular watch measures were considered essential as none of the different huts which form the depot has an outside entrance, all the doors of the huts opening, as said above, into the interior courtyard.

Only the hut where the theft was perpetrated had two windows toward the outside, on the street, but the breaking into the said windows was not to be foreseen because they are protected by a solid iron grating, because they are at a considerable distance from the ground and because they open on a main road carrying a large amount of traffic.

- 3) All doors of the depot were duly closed.

The hut in question has two entrance doors, both from the interior courtyard and therefore watched by the night guard. One door is usually barred from the inside and the other is regularly closed every evening. On the morning when the theft was discovered these doors were found regularly closed and without any signs of having been forced.

Besides the two a/m doors there ^{are} some small sky-lights high on the sides of the hut, and, on the outside wall opposite the Lungomare Fiera di Levante, two windows about 2 meters from the ground. One of these was found, the morning of the 18 Dec., forced by the violent bending of the protective iron grating which was done by breaking the the lower bars.

The two a/m windows, now walled up, were protected by solid grating, fixed in the wall-frame and closed internally with another fine-meshed wire screen. -

4) The CC.RR. who were in due course asked to investigate (as was the American Police) has denounced, as probable perpetrators of the theft, the following accused, all untraceable:

MANGINELLI Giuseppe living at BARI -28 Via Rismondi
 MERCADANTE Vito " " " 116 Brigata Regina
 SCIACOVELLI Vito " " " 341 Via Napoli.

Further denounced were other persons for receiving and selling sugar, as per enclosed report on the CCRR enquiry.

5) The presumable perpetrators of the theft have been denounced in absence, and further information will be forthcoming as soon as they are arrested.

6) We believe that the depot personnel cannot in any way be held responsible in as much as the theft was not due to any carelessness in the guarding and custody or to a lack of security measures.

The breaking in of the windows through which the theft was carried out could not be foreseen.

The breaking in, which certainly must have been difficult and operated by several strong persons, with levers and other instruments for cutting or sawing the ~~bars~~ iron bars, was facilitated by the fact that under the window in question the soil had been raised considerably in those days due to some nearby excavation job.

The undertaking of the theft was daring and could not be foreseen: According to ordinary foresight and practical prevention of thefts, windows protected by a good iron grating, ~~and~~ at the height of those in question, and opening on such a main road with so much traffic- as is the Lungomare Fiera di Levante- are not particularly vulnerable points and do not need special watching.

We therefore believe that the theft is to be attributed truly and properly to a major force.

CHE in relazione alla richiesta della M.M.I.A. (foglio ST/5317 del 13/1/945) comunicata alla Direzione di Commissariato con attergato in data 17 corrente, si è riunita oggi al magazzino viveri la commissione composta dagli ufficiali seguenti:

- Capitano Comm/rio Antonio Bettinardi
ambidue nominati dal Colon. Comm/rio Direttore in rappresentanza della Direzione di Commissariato di Bari
- Capitano Geo. C. Guzzie, intervenuto in rappresentanza del Distaccamento M.M.I.A.;

CHE in ordine ai quesiti proposti con foglio succitato della M.M.I.A., in merito al furto verificatosi nella notte dal 17 al 18 dicembre scorso anno al magazzino viveri, la commissione ha accertato quanto appresso:

- 1°) I quantitativi esatti delle derrate sottratte dai ladri che operarono il furto succitato sono i seguenti:
 - zucchero sacchi n. 42 da lbs. 60 = lbs. 2520
 - riso " " 1 " " 100 = " 100
 - Fismif. Prod. It. scat. 2000
- 2°) Le misure di vigilanza e sicurezza in atto per prevenire furti al magazzino in parola consistevano e consistono nella solida chiusura delle porte di accesso ai diversi padiglioni del magazzino, sporgenti tutte nel cortile interno del magazzino stesso e sorvegliate ininterrottamente nella notte da una guardia che in caso di sospetti o di incidenti era ed è in grado di dare allarme ai militari alloggiati nel dormitorio del magazzino.=

All'esterno nessuna particolare misura di vigilanza è risultata indispensabile non avendo nessuno dei diversi padiglioni componenti il magazzino alcuna porta o ingresso dall'esterno, poichè, come detto, tutte le porte dei padiglioni si aprono nel cortile interno.=

Solo il padiglione nel quale si è verificato il furto aveva due finestre sporgenti all'esterno, sulla strada, ma non era prevedibile lo scasso di dette finestre sia perchè protette da solida inferriata, sia perchè ad una certa altezza dal suolo, sia perchè sporgenti su strada di grande traffico e di primaria importanza.=

- 3°) Tutte le porte del magazzino erano debitamente chiuse.=

Il padiglione in argomento ha due porte di accesso, tutte due sul cortile interno e quindi sorvegliate dalla guardia notturna.= Una porta è abitualmente sbarrata dall'interno e l'altra viene regolarmente chiusa ogni sera.= Al mattino in cui fu scoperto il furto tali porte furono trovate regolarmente chiuse e senza tracce di forzamento.=

Oltre alle due porte suddette si aprono sui fianchi del padiglione alti lucernai di piccole dimensioni, e, sul fianco esterno di fronte al Lungomare Fiera del Levante due finestre all'altezza di circa due metri dal suolo. Una di esse fu rinvenuta il mattino del 18 dicembre forzata per il violento

ripiegamento dell'inferriata di protezione mediante la rottura delle sbarre inferiori. =

Le due finestre in parola, attualmente murate, erano protette da solide inferriate, infisse nell'incasso murale e internamente chiuse ancora da rete metallica a maglie strette. =

4°) L'amma dei CC.RR., tempestivamente interessata per le indagini (per le quali fu subito anche interessata la Polizia Americana) ha denunciato come probabili autori del furto i seguenti pregiudicati resisi tutti irrimediabili:

5°) I presunti autori del furto sono stati denunciati allo stato di latitanza, si fa riserva di comunicazioni non appena verranno tratti in arresto.
6°) Si ritiene di dover escludere ogni responsabilità del personale del magazzino in quanto il furto non è dipeso da negligenza usata nella custodia e vigilanza dei locali o da difetto di misure di sicurezza. =

Non era prevedibile lo scasso della finestra attraverso la quale fu operato il furto. =

Lo scasso, che certamente dovette essere laborioso e compiuto da più persone e robuste, con l'aiuto di leve e altri strumenti idonei a tagliare o segare le sbarre di ferro, fu favorito dal fatto che sotto la finestra in parola si era prodotto in quei giorni un notevole rialzamento del suolo dovuto a vicini lavori di sterro in corso di esecuzione. =

L'impresa ladresca fu temeraria e imprevedibile: secondo comune prudenza e pratica prevenzione contro i furti finestre munite di buona inferriata, all'altezza di quella in argomento, e poste su strada di notevole traffico ed importanza - come il Lungomare Fiera del Levante - non costituiscono punti vulnerabili e bisognosi di apposita vigilanza. =

Si ritiene pertanto l'evento del furto attribuibile a vera e propria causa di forza maggiore. =



This is the unit under which are grouped all the E M working for the numerous Commissariato units plus those that go on guard duty on trains which totalled 213 on the day of the inspection and are included in the attached report under the heading "In servizio isolato."

The barracks, former armored car garages, were clean and orderly but also cold and uncomfortable to men who are coming off long train trips and rest only about 24 hours before returning to duty.

The discomforts of train guard duty was emphasized by the C.O. and hoped that I would see fit to recommend a more ample and varied ration than the existing one, consisting of hard tack, a can of Spam that serves for 3 days and two oranges or nuts and figs.

This unit also includes 78 men located at 3 Via Carriba who constitute a band. The band was also investigated and it was found to consist of Non-Coms of the regular Army. They have not played since 11 November, with the exception of a few who play with some of the Allied units. The attached report also shows that there are 70 men on leave, of these 28 are members of the band.

RECOMMENDATIONS: That the Non-Coms constituting the band be ordered to more active work or if it is felt that the band is good for morale purposes that it play in hospitals and camps.





Subject: Unloading of goods in the port of BARI.

The unloading of goods that arrive in the port of BARI on the various cargo ships, and that are destined for this Bulk Depot, has been carried out for some time under considerable difficulties, because of various circumstances (changed atmospheric conditions, irregular arrival at the quays of the M.T. detailed for unloading, labour sometimes inadequate, etc.).

However the cause of the most critical impediment to the carrying out of the duties is the fact that there are completely insufficient places to store the goods received, either for numbers or for capacity.

The unloading of goods that arrive in the port of BARI on the various cargo ships, and that are destined for this Bulk Depot, has been carried out for some time under considerable difficulties, because of various circumstances (changed atmospheric conditions, irregular arrival at the quays of the M.T. detailed for unloading, labour sometimes inadequate, etc.).

However the cause of the most critical impediment to the carrying out of the duties is the fact that there are completely insufficient places to store the goods received, either for numbers or for capacity.
