2. Wagon No. 35193 was loaded and consigned by 46 BSB B&I on 30 June 1945, being received and off-loaded by 38 BSB MONTICANGIARO on 6 July 1945. The wagon had thus been approximately seven days in transit.

3. On off-loading a deficiency as detailed in para 1 was revealed. Seal No. 5246511 had been substituted by Seal No. 5246521 whilst the consignment was in transit, and the assumption of pilferage is borne out by the Train Guard Control Report (R/2/7361 dated 3 August 45) copy of which is attached.
