Premises can accomodate 60 convalescents but at present average strength is 40.
Recreation rooms with table tennis, radiogram etc., and bar are provided.
The whole place was exceptionally clean and well kept.

Rations

These are drawn from 806 Transit Camp. as the personnel are held on their strength following evacuation from hospital.

3. This Home is solely for Or's. It is well organised and the O.C. appears keen and interested in his job.

4. As this Home is not authorised on the ORBAT the above information is forwarded for any action that you may deem necessary.
