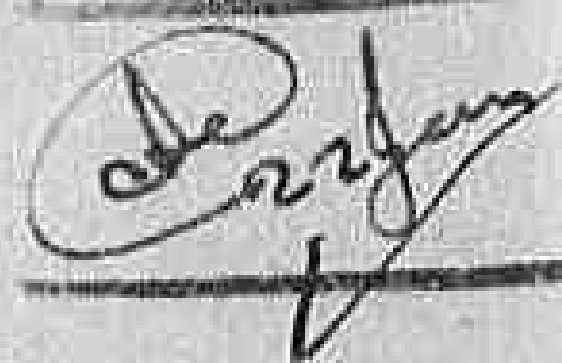

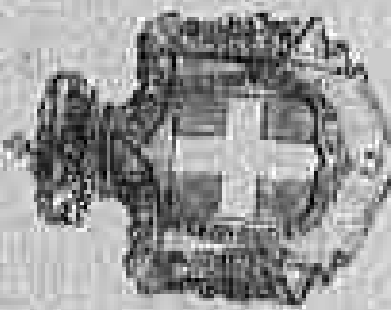

Repatriated POW's arriving in Italy are civilians and are therefore not a concern of MMIA nor the Italian Army in accordance with Par 6 of AFHQ letter, file AG 091.711/169 OCT-0, of 16 November 1944, subject: "Command and Administration of the Italian Army". The responsibility for handling these repatriated POW's is that of the Italian Civil Government, and it appears that any trucks needed must be furnished from their civilian pools. As this is civil work, no POL can be provided from Army allotments, as it is not possible for the Italian Army to requisition POL for civilian work.
