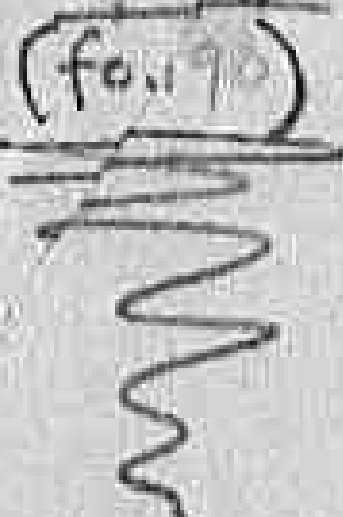

1. A copy M.M.I.A. Office Instruction N°76 is enclosed herewith - the provisions of which should assist you in clarifying the procedure. The items referred to in para 1 thereof are those which are normally held in stock in BR-ITI depots.
2. The position regarding other items of general stores is that they are in short supply and stocks in Italian depots are controlled by Q(AE) M.M.I.A.
Demands for these stores should be forwarded by the AM. Div. concerned in duplicate to the Italian Ministry of War and one copy should be forwarded by the M.M.I.A. L.O. concerned to this office.
3. It is appreciated that this procedure entails delay in supply of equipment to units being formed or reorganised at short notice but when controlled stores are urgently required, a signal or telephone message (confirmed by signal) from you will be accepted by this H.Q.
4. Ref. para 5 of AFHQ/6506/7/Q(AE) of May 45 - INTRODUCTION to BASIC EQUIPMENT LIST for BR-ITI SERVICE UNITS - it should be noted that the authority to issue certificates of non-availability of stores from Italian resources rests with this H.Q.

5. Regarding the issue of vehicles and MT assemblies and spares to BR-ITI units - it has hitherto been generally understood by all concerned that no vehicles or spares have been available from Italian sources for issues to BR-ITI units and releases of British vehicles and spares have been obtained from H.Q. District or other British H.Q. concerned.
