According to this letter it would appear that I am to be downgraded from T/Major to W/Capt for the period 12 Dec 44 to 9 Feb 45, and then granted A/Major pending re-grant of T/Major. I should therefore like to point out that I was posted from R.A.C.T.D. as T/Major to Land Forces Sub Comm (MMIA) to command British Cadre of an Italian Reinforcement Depot.

On the 12 Dec 44 I reported to H.Q. Land Forces Sub Comm (MMIA) and received instructions to open up a Reinforcement Depot at Orvieto as O.C. British Cadre. On the 13 Dec 44 I was instructed to report to H.Q. No.1 District who were held to be the Supervisory Authority; from here I was directed to proceed to H.Q. No.71 Sub Area to make contact with the various services, and then to proceed to Orvieto and commence my duties.

On the 16 Dec 44 a sitting board was held on the barracks, and it was decided suitable to accommodate 3,500 troops. Stores etc commenced to arrive 24 Dec 44. Permanent staff (Italian) were also arriving, and by the 27 Dec 44 the first batch of 500 call-ups arrived and up to the 8 Feb 45 I had handled 6,303.
