SUBJECT:- Application of the Legislative Decree of the Provisional Head of the State 13 September 1946 n.303.

The Legislative Decree of the Provisional Head of the State of 13 September 1946, n.303, published in the Official Gazette of the Italian Republic n.264, of 20 November 1946, has cancelled the Lieutenantcy Legislative Decree 5 May 1946, n.418, which extended the instructions in force relative to the retention of employment in case of recall to service, to the citizens of the 1924, 1925 and 1926 classes called to service for the fulfilment of levy obligations which, at the time of the call-up, were at least one year's service.

The same Legislative Decree n.303, lays down, instead, that for all workers of the 1924 and successive classes, and for those of preceding classes exempted for some reason until the call-up of said classes, the call to service to fulfil the levy obligations suspends the terms of employment ~~and~~ for the total period of military levy service and the worker has the right of retention of employment.

The worker must have been, previous to call to service, under the same employer for over three months.

For said right to be effective the persons concerned must make due request within thirty days from the date of release from military service from sending on indefinite leave awaiting release. For those who are in said positions on the date of entry into force of a/m Legislative Decree n.303 (21 November 1946) the presentation of the request must be made within thirty days of the publication of same Decree.

Failing this the terms of employment must be considered as concluded.

The above cited Legislative Decree n.303 is also applicable to casual and daily personnel, as well as to salaried personnel of the State administration.

We think it advisable to warn that the recommencement of ^{employment} service, on the basis of above cited Legislative Decree, must be authorised, case by case, exclusively by this Ministry, to which, therefore, the requests of the persons concerned, duly documented, must be forwarded.



Discussed the question of the Albanians with VENTURA pointing out that the recent decree put Albanian personnel in a different category to that of It. Army personnel. VENTURA realized this but stated that this particular decree, although only recently published, had been decided upon before Decree 384 applicable to It. Army personnel. This Albanian case had already been put to the H. of W. by Col. SIBACHIV and was being gone into although it is not thought that much will come of it for the following reasons :

- i) It. Army officers not willing to serve and swear allegiance to the Republic were going to be treated in the same way as the Albanians.
- ii) It. Army personnel were never treated in a very kind way and any particular favourable treatment to these Albanians might result in political trouble.

Took up the question of Albanian soldiers that had previously been incorporated into the It. Army. Requested what arrangements the M of W intended to make for such personnel.

Gen CHIARIAN stated that this was a matter that had been given a considerable amount of attention by the Council of Ministers and that the new decree on this subject had just been issued. Albanian personnel would be granted the same rights as Italian personnel of the equivalent rank and that there were now full facilities for such as desired to become Italian citizens and settle down in Italy.

Dear Admiral,

Following the note of the President of the Council of Ministers, No. 11468, dated 16 October 1946, I wish to inform you that the insertion of the new Art 46 (A) in the scheme of the Peace Treaty requires no organic changes or new measures regarding military personnel, since the necessary measures were taken some time ago by the Military Administrations in order to remove the officers and non-commissioned officers of the fascist militia or of the fascist republican army.

I can even specify more precisely that the measures taken by the Italian authorities go beyond those provided in Art. 46 (A), as, not only members of the fascist military organizations are excluded from the Italian Army, but, owing to the provisions taken for the reduction of the military cadres, even those officers and non-commissioned officers who, having been absolved after having been submitted to disciplinary action, are now being removed or are about to be removed.

Following is the text of GCS signal FAN 711 dated 11 Jan. 47 for your information. Quoted reference RAF 1173 and RAF 1290.

- Para 1^o) - You should abolish ALCON within 21 days from the receipt of this directive irrespective of the date of the signing of the revised Armistice terms.
- Para 2^o) - You are authorized to establish an Italian Military Affairs ~~SECT~~ Section (IMAS) ~~AM~~, to be charged with the control functions of supervision and direction of the Italian Armed Forces, heretofore exercised by the Land, Navy and Air Forces subcommission in Alcon. This section shall control the size and character of all Italian armed forces and the production of armaments.
- Para 3^o) - The remaining functions presently performed by Alcon, apart from those connected with the Italian Armed Forces, will be transferred to G-5 ~~AM~~ to include the following, Sub Para (A) - furnishing of technical advice and guidance to, but not rpt not exercise of command of a Allied Military Government agencies. Sub Para (B) - Review of military court cases. Sub Para (C) - Responsibility for the administration of Displaced Persons agencies and Camps. Sub Para (D) - Responsibility for Allied Military Government military imports. Sub Para (E) - Maintenance and disposition of Alcon files.
- Para 4^o) - You are authorized to establish in Rome a Liaison subsection of the G-5 Sec. (?) to ~~maintenances~~ maintain liaison with the Italian Government. It is not rpt not considered that this liaison section or IMAS should retain subcommission structure or bear any resemblance

SUBJECT: Production of the mechanical workshops.

Refer to R. beach letter no. 2 004 of 24 Sep 46

1. From the statistic data received, it appears that the weekly output of repairs carried out at the repair units (which were approximately 480 in the first six months of 46) has lightly decreased during the months of Aug and Sept, having dropped to 460.

2. This is due, besides the reason indicated by you, to the disbandment of Nos. 1 and 2 Mobile Parks and, above all, to the fact that from time to time when the LADs of the M.T. units, mobile Battalions and Carabinieri Legions commence to function, the majority of class 1 repairs and a few of class 2 repairs are carried out by the units themselves and therefore not entered in the weekly repairs.

For the same reasons the repair units, having to carry out almost all repairs of classes 2 and 3, which require more personnel and time, must show, compared with the past, a numerical reduction in the weekly out-put.

3. Regarding the administrative work carried out by the chiefs of the Repair units it is known that the renewal of the peace administrative rules, (w.e.f. 1st July) absorbs a notable part of their activities. Unfortunately it is not possible to quickly change the laws in force, which aim at a severe administration of public funds. However provisions have been proposed - and we hope that they will be quickly approved - which will notably facilitate the management of unit accounts, permitting a speedier carrying out of the matters concerned.

4. The assignment of the funds to repair units depends on the relative allotment of the budget which cannot be exceeded. A temporary crisis in the availability of the funds has been caused by the substitution of the war administrative rules with the peace administrative rules. This has provoked a temporary less frequent assignment of funds to the local units as it was not known, then, the amount of the new allotments.

Said difficulties have now been overcome and the assignments of funds are proportioned to the importance of the repair units, to their production output and to the number of vehicles running in the territory under their jurisdiction.

5. The employment of the personnel for Repair units was previously made in a manner not always connected with the technical efficiency

required for the carrying out of the duties, as tradesmen were not available, due to them all being employed by civilian workshops with a very high rate of pay.

The prohibition of dismissals does not permit, at present, the necessary substitutions. We hope for a better future as soon as the less capable personnel can be dismissed.

6. Regarding the mess-halls and other accommodations of economical character for the workers, we would point out that they have been by this time, set up in almost all military workshops and spare parts stores and that soon they will be also set up in the repair units that still do not possess them.

1. The Mission under my command is responsible for giving advice on organisation, training and administration to the Italian Army, based where applicable on our own methods.
2. Personnel selection in the Italian Army is a complicated problem and one of which the Italians have very little experience. The result is that when the 40,000 recruits (this number are called up 3 times a year) have completed 1 month training the best are picked for further training as Gunners, Sappers, and for specialist jobs in the Services while the Infantry get the "left overs" which are invariably the worst.
3. I am trying to put over to the Italians British experience which has shown that so much is required of the modern infantryman that steps must be taken to see that the Infantry get men as good, if not better, than those selected for any other arms.
4. I know that both Field Marshall Wavell and Field Marshall Montgomery have stressed this point in speeches and in documents from time to time and that Arthur Bryant wrote a very fine article on the subject in the "Times". It may well have been mentioned in War Office training pamphlets or Infantry Training Bulletins or elsewhere.
5. We have no copies of the above or any reference library here and no access to speeches except those published in the Press which we may or may not see.
6. It would greatly strengthen my case if I were in a position to quote some British official opinion and I should be very grateful if you could give me any extracts from written or spoken opinions from official documents on the subject.

It appears however, that there are 100 - 150 Army personnel on the active list functioning under UFFICIO SUSSIDI e PENSIONI MILITARE and domiciled in Zone A.

It is possible that HQ may require the Morgan agreement to be enforced. Should this be the case there would appear to be only two alternatives

My dear Mr. Prime Minister,

You are no doubt aware of the amendment to Article 52 of the draft Italian Peace Treaty which was discussed by the Military Commission in Paris about 3 September. I have been informed that it was agreed to insert a new Article No. 40 (A) to the effect that in no case shall any officer or non-commissioned officer of the former Fascist Militia or the former Fascist Republican Army be admitted with Officer's or non-commissioned officer's rank to the Italian Army, Navy, Air Forces or Carabinieri with the exception of such persons as have been exonerated by the appropriate body in accordance with Italian law.

I am not aware, my dear Mr. Prime Minister, to what extent this new clause may affect the Italian Armed Forces, but I feel sure that you will want to take such action as may be advisable at this stage.

Enquiries made with regard to the employment of tradesmen in the Italian Army have suggested the following:-

1. The present policy seems to be the employment of local labour to an overwhelming extent.

There appears to be no policy of building up a body of skilled tradesmen specialised in the peculiar needs of the service.

Preference appears to be to pay extremely high wages (comparatively) to civilians rather than to create a reasonably paid, efficient nucleus of soldiers on whom reliance can be placed to do their duty without political or labour bias in whichever place their services are of most benefit to their country.

2. It is submitted that if the Ministry of War would implement a policy for the progressive increase in pay and rank for tradesmen according to their abilities, the following benefits would accrue:-

- (a) Save expense.
- (b) Build up a force with special knowledge capable of supervising civilian labour in case of expansion.

(c) Create a contented and loyal force of workers available for deployment as and when needed.

(d) Give an incentive to regular service.

(e) This would have no effect on unemployment as the soldier must be considered as employed.

3. In initiating this policy the following points should be considered:-

(a) The ordering of standard trade tests with resulting benefit in rank and/or pay.

(b) The soldiers should enlist for (say) a seven years term of colour service with the possibilities of re-enlistment if approved up to pensionable age.

4. It is known that the authorities say that when the schools have passed out the learners tradesmen at present undergoing instruction there will be no shortage of tradesmen or specialists.

The point is that an efficient tradesman cannot be turned out in a few months and that when his service is the normal period of compulsory service he has no sooner joined his unit than he is beginning to think of his discharge.

5. The content of this letter has been written with the Mechanical Transport service in mind.

6. A study of the Army list of Tradesmen reveals many analogous trades. These should be cut down to parent trades so that the specialist is really a specialist.

We may be able to take this matter up again when there is a new Minister of War.

3. Notes on ITALIAN Equipment

ITALIAN equipment and weapons were, with one or two exceptions, old and obsolete before the war and are even more so now. The ITALIAN formations equipped and armed with ITALIAN material provide a very pathetic spectacle alongside those equipped from BRITISH sources.

Existing ITALIAN military MT is heterogeneous, antiquated and very much below establishment.

4. POTENTIALITIES OF ITALIAN INDUSTRY TO RE-EQUIP THE ITALIAN ARMY(a) Heavy Weapons and "L" Vehicles

Manufacture at present prohibited under Armistice terms.

Even if allowed under the Peace Treaty, it would be some years before the ITALIAN armament industry could be re-built sufficiently to design, test and produce the necessary quantities of modern material to re-equip the ITALIAN Army.

(b) Machine Carbines, Pistols etc.

These could be produced in sufficient quantities and of good design at short notice if allowed by Peace terms and if sufficient raw materials, coal and labour were made available.

(c) M.T.

The ITALIAN Motor Industry is returning slowly towards normal but is hampered by lack of raw materials. It will eventually be able to provide all requirements for ITALIAN military MT but it will take at least 2 years to do so.

5. VITAL MANPOWER IN THE PRESENT ITALIAN ARMY(a) Infantry Divisions

As can be seen from the table in Para 1., these Divisions are in need of reconn. issue units and of a considerable higher scale of artillery if they are to be capable of operating efficiently and unsupported by ALLIED troops. Owing to the limitations given in Para 4(a) and also to the necessity for conforming with existing equipment in the Divisions, additional requirements can only be met from BRITISH sources.

New establishments and Divisional organizations have been worked out with the ITALIAN authorities and the extra personnel required have been earmarked from potential savings in the administrative ceiling but implementation cannot take place until weapons and equipment are made available.

(b) Internal Security Divisions and Independent Regiments

The I.T.L.L.M. Motor Industry is returning slowly towards normal but is hampered by lack of raw materials. It will eventually be able to provide all requirements for I.T.L.L.M. military but it will take at least 2 years to do so.

5. VITAL FACTORS IN THE PRESENT I.T.L.L.M. SITUATION

(a) Infantry Divisions

As can be seen from the table in Para 1., these Divisions are in need of re-organisation units and of a considerable higher scale of artillery if they are to be capable of operating efficiently and unsupported by L.I.F.E. troops. Owing to the limitations given in Para 4(a) and also to the necessity for conforming with existing equipment in the Divisions, additional requirements can only be met from BRITISH sources.

New establishments and Divisional organisations have been worked out with the I.T.L.L.M. authorities and the extra personnel required have been earmarked from potential savings in the administrative ceiling but implementation cannot take place until weapons and equipment are made available.

(b) Internal Security Divisions and Independent Regiments

The fact that this half of the Army is equipped with antiquated I.T.L.L.M. weapons produces the following serious consequences:

- (i) The training problem is acute. For simplicity, and in anticipation of a decision to re-equip the whole I.T.L.L.M. Army with BRITISH weapons, all recruits now being called up and trained at the Recruit Training Centres are being trained on BRITISH weapons. Central Schools also have their instruction on BRITISH weapons. If Internal Security Divisions and Independent Regiments are to remain on I.T.L.L.M. equipment, the training of many of these now passing through the mill will have been inappropriate and in future, training centres and schools will have to cater for a dual type of training that will cause much difficulty, complication and waste of effort.

- (ii) It is at present impossible to transfer an Infantry Regt or Battalion from one part of the Army to the other without re-equipping it with a strange type of weapon and re-training it with its new equipment.

It is considered essential that Regiments and Battalions should be readily transferable as between Infantry Divs, Internal Security Divs and Independent Regts, and this can only be done smoothly if the whole is equipped alike.

(iii) As long as one unit of the Army continues to be equipped with obsolete material as opposed to the other, its morale and general efficiency are inevitably greatly depressed.

It is only necessary to visit units of the Infantry Divs and those of the other formations to note at a glance the extremely marked differences in military value between the different categories.

(c) Replacements and spares

At present when any BRITISH weapon or vehicle on the establishment of an ITALIAN unit is repaired, it becomes a loss to the establishment as no replacement is available to take its place while it is being repaired.

In addition, if the repair involves the substitution of a new spare part for a broken or worn out part, the equipment becomes a total loss as no spares are forthcoming.

As mentioned in para 2, 60 days maintenance for existing BRITISH vehicles and weapons has been promised, but this will only fill a small portion of the present and future requirements.

7. CONCLUSION

(a) In view of the small size of ITALIAN requirements in comparison with world-wide BRITISH surpluses, and on the accepted basis that the formation and maintenance of a small but efficient ITALIAN Army is essential from the point of view of EUROPEAN and MEDITERRANEAN security, it is considered that the provision of the BRITISH equipment asked for is essential and will not very small drain on our available resources.

(b) No consideration has been given in these notes to the financial aspects involved or those which are outside the scope of this Mission, but it is suggested that both from the strategic and economic aspect, the cost to ITALY should be made as low as possible.

(c) These notes have considered only the requirements of the Interim ITALIAN Army. Should the peace terms permit the ITALIANS to have a larger Army than at present or permit the Army to have in it weapons and equipment not at present allowed, further problems of equipment will arise and require decision. Nevertheless, such extra provision commitment would in any event be relatively small compared with the BRITISH resources available and otherwise unused or turned into scrap.

(d) The advantages and control afforded to the ALLIES, even after the Peace Treaty, by equipping the ITALIAN Army now with BRITISH equipment needs no emphasis.
