

SUBJECT: German prisoners in French custody.

For quite a long while the press of the country has been calling to the attention of the public, the particularly hard treatment shown by the French to the German POW in their custody.

As is known this matter, not only in contrast with the Geneva Convention, but also contrary to all human principles, was also discussed in the French Press.

Following these attacks and due to the result of inquiries conducted by the American authorities, the latter suspended while ago, the assignment to France of the German prisoners that they had agreed to turn over.

The Press has now announced that a favourable and complete solution of the problem has been rejoined and assurance, on the part of General Juin and General Eisenhower have been given that from now on, the German prisoners will be treated according to the Geneva Convention. In consequence of this agreement the transfer from U.S. Custody to French Custody will begin at the rate of 50,000 men a month, at present in the U.S.A. while the American Army will receive from the French about 90,000 prisoners who are in bad health who will be taken care of and subsequently released. The United States will in more, for each prisoner assigned to the French, furnish a certain quantity of food and clothes.

It is noted with great satisfaction that owing to this agreement 200,000 men of the Africa Corps will be transferred to France, who have been housed and well fed in the American camps, and are considered as being ardent nazis and therefore a source of trouble for this country.





TO: Commanding General, MTOUSA, APO 512, U. S. Army

1. Basic letter and inclosed letter from Ministry of War are similar to a letter from Land Forces Sub Commission, AG (MMIA), APO 394, dated 31 October 1945, addressed to your headquarters and inclosing a letter from the Minister of War. That letter was forwarded here by 1st indorsement dated 8 November 1945 and reply was made to you by 2nd indorsement dated 27 November, signed by General Oxx, giving a complete report on the situation in Leghorn.
2. The complaints made in the inclosure hereto which are essentially the same as reported in the earlier letter have again been investigated and are believed to be without basis in fact.
3. Local officials state that they have made no complaints to the Minister of War. There appears to be no active resentment toward the German prisoners other than a general dislike of their presence here. There has been nothing to indicate the probability of any "incidents". It is noted that the Minister's latest letter is dated 13 November. Obviously he could not have been informed of the facts reported by this headquarters since they were contained in an indorsement of a later date.

SUBJECT: Leghorn - German Prisoners

TO : Land Forces Sub Commission, AC (MMIA)

Further reports in the possession of this Ministry point to the serious agitation which reigns amongst the population of Leghorn due to the employment of German prisoners in place of Italian workers.

The people are exasperated by the impudent behaviour of these prisoners and the liberty they enjoy.

The conduct of those employed as drivers is particularly provocative; the vehicles are driven at excessive speed even in the most crowded roads, with serious danger to the public; the drivers ignore the signals given by the Italian troops on duty at the busiest traffic crossings. This has caused a deep resentment, and it is possible that serious incidents may arise.

In view of the situation becoming worse, we again earnestly appeal to your Mission to take necessary action in this matter in order to eliminate the causes of this discontent.



EXTRACT COPYSTATEMENT OF COMMANDING GENERAL, PBS

1. There was a time when the people of Leghorn were reported to be disturbed by not only the treatment accorded German prisoners but also the mere presence of German prisoners. As evidence of how this situation was handled, I inclose an extract copy of remarks included by the AMG officials of Leghorn in their October report to the Allied Commission. Reports that the public morale is bad because of this question are not founded on fact. No complaints have been received in this headquarters since date of meeting referred to in the inclosure.

2. ~~None~~ Neither have I nor the responsible officers of my command observed any indication of arrogance or scornful behavior on the part of German prisoners. Even though it is undoubtedly true that the average German opinion of Italians is not high, the conduct of the German prisoners has been remarkably good.

3. German prisoners enjoy no freedom or privileges, and are not housed or fed, in a manner not provided for in existing directives and by the terms of the Geneva Convention. All work parties outside cages are either under guard or supervision of U. S. Army personnel.

4. No German prisoners are billeted in facilities whose occupancy is depriving Italian civilians of homes. In only one case could a violation of this rule be inferred. A small group is housed in the upper floor of what was once a school building. This building, which is surrounded by a barbed wire fence, houses the Central Records Bureau, in which practically all work is done by POW, and has been retained by this headquarters due to the fact that no other suitable facilities have been available within a reasonable distance of headquarters. However, with the consolidation of all POW activities in the former staging area, which is now in progress, the school building in question will be vacated. It is anticipated that approximately one month will be required to properly fence the areas to be used for all POW enclosures and installations.

5. The Prefect of Livorno Province and the Sindaco of Livorno both are in constant touch with this headquarters and both know that they are free, and encouraged, to make specific complaints to me, through AMG. If persons other than the responsible Italian governmental officials and civic leaders have any specific complaints, I should be happy to correct the indicated delinquencies if, in fact, such exist.

STATEMENT OF LIVORNO ZONE PUBLIC SAFETY OFFICER

* * * * *

6. Appreciation of the General Security Situation. As pointed out in 4 above, the State of Public Morale is very good. Much credit, for this condition, is due in a large part to Brigadier General Francis H. Oxx, Commanding General of the Peninsular Base Section of this theater. About the first part of this month there was a rapid development of unrest among the people of the Livorno Zone area. Approach of winter was a factor. An ever increasing number of unemployed was another. The most potent of all, was the presence of German P.O.W.'s working in dumps and around installations; and of course the ever flourishing gossip mill that Italians dote on. Civic, Political and Labor leaders were hard pressed to keep the situation in their control. Military circles were aware that something was brewing, and this officer had come in to A.C. Headquarters to discuss the situation with higher level. The Naples disorders were still fresh in mind. At this juncture General Oxx took hold, and settled the whole thing in just 49 minutes.

A meeting was called by General Oxx for 1400 hours on 4 October 1945 in his office at P.B.S. Headquarters, Leghorn. Civic, Political and Labor leaders sat down with Military representatives. Those present were:

- Brigadier General Francis H. Oxx, Commanding General P.B.S.
- Colonel Harrison Shaler, Chief of Staff, P.B.S.
- Major Harold V. Reilly, Livorno Zone Commissioner, A.M.G.
- Captain Stanley Beatty, Livorno Zone Public Safety Officer, A.M.G.
- The Prefect of Livorno Province, Sig. Francesco Miraglia
- The Sindaco of Livorno City, Sig. Furio Diaz
- Francesco Gosselli, President National Party of Liberation
- Aldo Augustanelli, Sect'y, National Party of Liberation
- Armando Gigli, General Director of the Camera Lavora
- Count Lorenza Rouelle acted as official interpreter for the meeting

It was a serious meeting, but a cordial one. The entire subject matter was played straight across the board. The timing element was deadly accurate; almost uncanny. Not too soon. Not too late. It was psychology at its best.

General Oxx asked if there were any specific charges that Military units were violating the Prisoner of War code, ^{the} ~~the~~ detriment of Civilian labor. There were none. He inquired if anyone present felt that P.B.S. or other Military groups had unnecessarily imposed upon the civilians population beyond reasonable military needs. There had been no such impositions. There had been some general gossip, but certainly nothing upon which even a skeptic would term an aggravated or deliberate act. The General made it clear that he would tolerate nothing of the kind. The meeting swung into question and answer stage:

Would property be deaquisitioned? How soon? Would there be additional lay-offs of common laborers and semi-skilled workmen? In what volume? Would German P.O.W.s replace Italian workmen? Would the Livorno Port be opened for civilian use? What about raw materials? There were numerous other questions, too, of less importance.

General Oxx supplied all the answers, direct and to the point. He had figures and statistics. Property was being deaquisitioned every day. There would be lay-offs only when units closed up and moved away. German P.O.W.s had never replaced civilian workmen--they had only replaced Italian military and Italian POWs. German POWs were being moved from the area as quickly as transportation facilities would permit, so that eventually only small numbers would remain. Yes, the Port area would be open for civilian use, and plans were well advanced to that end. Some raw materials would be available to make a start at general rehabilitation. He pointed out that the Italians must not expect the Army to set up a WPA. The Army would use the maximum of Italian labor so long as it was needed. He warned them that the time was drawing near when there would be few, if any, military installations remaining. The Italians must realize that the time was approaching when he must prepare his own destiny.

The whole thing required 40 minutes. Italians are quick to react to a given situation that involves themselves. Within 24 hours, the leaders had arranged meetings with their groups and sub-leaders.

The day previous to this meeting, the Civic, Political and Labor leaders were in a bad way in Livorno. Public confidence was hanging by a thread and the leaders could give the people no definite answers. The day following the meeting, the situation was in direct reverse. The leaders had the answers and lost no time in laying the entire situation before their followers. The leaders' position was further enhanced by the fact that General Oxx had gone over the whole subject with them. Rumors ceased to fly and the general atmosphere cleared in the interior. The General restored the prestige of the leaders and they in turn were able to grasp a new hold on their wavering followers.

The leadership in Livorno is both intelligent and cooperative with the Military forces. P.B.S. and General Oxx, as an individual, is held in high esteem and respect by the entire population. He took them into his confidence as their next best friend and they loved it. Public Morale is very good in the Livorno Zone.



It is reported to this Ministry that the people of Leghorn are greatly disturbed by the treatment given to German prisoners stationed there.

Concerning this, the people state that such prisoners, besides enjoying a fair amount of freedom, made more evident by their scornful behavior toward the people, are also comfortably billeted in various premises in the city, including school buildings.

With a view to eliminating such reasons for discontent, that might possibly bring about regrettable incidents, above all by the fact that many workers' families are left without a roof due to damage caused by the war, I think it advisable to report the matter to you for any action you may think necessary to take regarding the matter.

Oxx, Commanding General of the Peninsular Base Section of this theater. About the first part of this month there was a rapid development of unrest among the people of the Livorno Zone area. Approach of winter was a factor. An ever increasing numbers of unemployed was another. The most potent of all, was the presence of German P.O.W.'s working in dumps and around installations: and of course the ever flourishing gossip mill that Italians dote on. Civic, Political and Labor leaders were hard pressed to keep the situation in their control. Military circles were aware that something was brewing, and this officer had come in to A.C. Headquarters to discuss the situation with higher level. The Naples disorders were still fresh in mind. At this juncture General Oxx took hold, and settled the whole thing in just 49 minutes.

A meeting was called by General Oxx for 1400 hours on 4 October, 1945 in his office at P.B.S. Headquarters, Leghorn. Civic, Political and Labor leaders sat down with Military representatives. Those present were:

 Count Lorenza Rouelle acted as official interpreter for the meeting

It was a serious meeting, but a cordial one. The entire subject matter was played straight across the board. The timing element was deadly accurate; almost uncanny. Not too soon. Not too late. It was psychology at its best.

General Oxx asked if there were any specific charges that Military units were violating the Prisoner of War code to the detriment of Civilians labor. There were none. He inquired if any one present felt that P.B.S. or other Military groups had unnecessarily imposed upon the civilians population beyond reasonable military needs. There had been no such impositions. There had been some general gossip, but certainly nothing upon which even a skeptic would term an aggravated or deliberate act. The General made it clear that he would tolerate nothing of the kind. The meeting swung into question and answer stage:

Would property be derequisitioned? How soon? Would there be additional lay-offs of common laborers and semi-skilled workmen? In what volume? Would German P.O.W.s replace Italian workmen? Would the Livorno Port be opened for civilian use? What about raw materials? There were numerous other questions, too, of less importance.

General Oxx supplied all the answers, direct and to the point. He had figures and statistics. Property was being derequisitioned every day. There would be lay-offs only when units closed up and moved away. German P.O.W.s had never replaced civilian

workmen--they had only replaced Italian military and Italian POWs. German POWs were being moved from the area as quickly as transportation facilities would permit, so that eventually only small numbers would remain. Yes, the Port area would be open for civilian use, and plans were well advanced to that end. Some raw materials would be available to make a start at general rehabilitation. He pointed out that the Italians must not expect the Army to set up a WPA. The Army would use the maximum of Italian labor so long as it was needed. He warned them that the time was drawing near when there would be few, if any, military installations remaining. The Italian must realize that the time was approaching when he must prepare his own destiny.

The whole thing required 49 minutes. Italians are quick to react to a given situation that involves themselves. Within 24 hours, the leaders had arranged meetings with their groups and sub-leaders.

The day previous to this meeting,--the Civic, Political and Labor leaders were in a bad way in Livorno. Public confidence was hanging by a thread and the leaders could give the people no definite answers. The day following the meeting, the situation was in direct reverse. The leaders had the answers and lost no time in laying the entire situation before their followers. The leaders' position was further enhanced by the fact that General Oxx had gone over the whole subject with them. Rumors ceased to fly and the general atmosphere cleared in the interim. The General restored the prestige of the leaders and they in turn were able to grasp a new hold on their wavering followers.

The leadership in Livorno is both intelligent and cooperative with the Military forces. P.B.S. and General Oxx, as an individual, is held in high esteem and respect by the entire population. He took them into his confidence as their next best friend and they loved it. Public Morale is very good in the Livorno Zone.



1. Paragraph 10 d is amended by the deletion of so much thereof as reads:

"The above will be reported on a new Casualty Form which will be prepared by GHC 2d Echelon and distributed. Until this Form is available casualties will be reported by units on the British Form AF W3011 if available, and if not available, by letter or other document which clearly shows:

- The name of the unit making the return
- The nature of the casualty
- The name and Wehrnummer of the individual to whom the casualty relates"

"The above will be reported on GMP Form 97 (GME/SEP 1) - Report of Casualties occurring in German Service Units."





INSTRUCTIONS FOR ORGANIZATION AND ADMINISTRATION
OF GERMAN SERVICE UNITS UNDER BRITISH CONTROL IN ITALY AND AUSTRIA

1. SELECTION AND ORGANIZATION OF PERSONNEL.

a. Headquarters Number 1 District or later such headquarters as may be designated from time to time by this headquarters will be responsible for selection of personnel now concentrated near RIMINI to meet initial requirements for service units shown on Priority List Ten (letter this headquarters, AG 386.3/163 OCTO dated 11 Jul 45 refers). In British Troops in Austria will be responsible for screening and reorganization of existing units in AUSTRIA.

b. German personnel will be drawn from all categories of the German Army, with the proviso that recalcitrant groups listed at Appendix 'A' will NOT be employed unless other Germans in the status of prisoners of war or surrendered enemy personnel are not available.

c. Recalcitrants will NOT be used on projects of a technical nature where opportunities for sabotage exist, or where proper and adequate guard cannot be provided (see para (graph 8)).

d. Prisoners of War, Surrendered Personnel and nationalities other than Germans will be kept separate.

e. Where personnel suitable for specific employments do not exist among the British holdings, application will be made by headquarters in paragraph 1a above direct to CC NEUGSA Prisoner of War Command to arrange transfer of such tradesmen as may be available in United States custody. This procedure will operate also in reverse.

f. All units operating outside the RIMINI concentration area will be provided with British Administrative Cadres. British technical personnel may be added to cadres where German units are not in the form of increments to existing British units.

2. WAR ESTABLISHMENTS.

a. All units will be formed on to War Establishments approved by the War Establishments Committee at this headquarters. War establishments for German personnel may be based on German organizations or on standard or ~~staff~~ War Establishments. War Establishments for British Cadres will be

1. SELECTION AND ORGANIZATION OF

a. f. All units operating outside the RUMINI concentration area will be provided with British Administrative Cadres. British technical personnel may be added to cadres where German units are not in the form of increments to existing British units.

2. WAR ESTABLISHMENTS.

a. All units will be formed on to War Establishments approved by the War Establishments Committee at this headquarters. War establishments for German personnel may be based on German organizations or on Standard or ~~Staff~~ Mediterranean Establishments. War Establishments for British Cadres will be entirely separate from War Establishments for German personnel.

b. All proposed establishments or amendments to existing German Army establishments will be submitted for consideration by the War Establishments Committee through G-3 (AMO) this headquarters, to whom ten copies will be sent. Services will submit proposals through G-1 (S), C (Maint) or G(AE). When proposals are received from formations outside this headquarters, G-3 (AMO) will forward them to the Staff Branch concerned before passing them to G-3 (Or. 3) for the War Establishments Committee.

- c. Proposals submitted by branches or sections of this headquarters must be signed by the Head of the Arm or Service concerned and also by the Head of the Staff Branch sponsoring the proposal. The form of the proposal is shown at Appendix 'B'.
- d. A representative of the sponsoring branch will attend the War Establishment Committee Meeting fully briefed as to the necessity of each item of the proposal.
- e. Establishments will be issued by this headquarters without a German translation. Supervisory authorities will arrange translation into equivalent German ranks and trades.

3. PRIORITIES FOR FORMATION AND PROGRESS REPORTS.

a. Priorities were originally allotted on List Ten at date of publication on the following basis:

- (1) Units urgently required
- (2) Units required within six weeks
- (3) Units required within three months
- (4) Units required within six months

b. In making fresh applications for new German units, priorities required should be quoted on a similar basis. C-3 this headquarters will be responsible for adjustment of requested priorities in relation to earlier bids. Where special dates are to be met, they will be shown in the 'Remarks' column of Priority List Ten. Priorities will now be taken to denote sequence of formation which will proceed at maximum speed until all units are formed.

c. It is intended that formation of all units within any one priority should proceed concurrently as soon as W's are known. Where space or other considerations make this impossible, a proportion of units from each service within the priority will be formed simultaneously, subject to any special priorities notified by C-3 through List Ten.

d. Supervisory Authorities will forward weekly progress reports on formation of units in accordance with the proforma at Appendix C., copies of which will be forwarded to AFHQ Services concerned.

c. Implementation of amendments to War Establishments will be automatic except when a note is included stipulating that the amendment is "not to be implemented without AFHQ authority" in which case formal application will be made as in paragraph 4b above.

5. EQUIPMENT AND CLOTHING

a. In general, supply of clothing and equipment to Surrendered Personnel will be through normal Ordnance channels. Maximum use must be made of Captured German stocks of clothing, equipment and transport of all kinds and issue from British stocks to meet deficiencies in Captured stocks will only be made from stocks specifically released to Army/Districts by this headquarters for that purpose. The list in no way constitutes an authority to draw any item listed from British Ordnance Depots. Equivalent German items will be used from Captured stocks and bulk issues from British stocks to meet deficiencies will only be made on authority of this headquarters.

6. MOVEMENT OF PERSONNEL OR UNITS.

d. In principle, when German units and reinforcements are moved by rail, they will be dispatched in formed parties of sufficient size to permit economical loading and hence to require a correspondingly small escort. Movement of individuals or very small groups will be avoided wherever possible.

e. Movement by rail will fall into one of the following three classes:-

h. Recalcitrant personnel will require minimum escorts, with adequate reliefs, of 5/8 under all circumstances.

1. The Army or District in whose area the move originates will be responsible for provision of guards for the journey. The receiving formation will dispatch the train escort party and latrine buckets back to the point of origin by the quickest means.

7. ACCOMMODATION AND WORK SERVICES.

a. German units may occupy accommodation which has formerly been occupied by Allied or Italian units provided that the local commander is satisfied that such accommodation can be adequately guarded. It is preferable that as far as possible Germans should not be accommodated in close proximity to either Allied or Italian troops.

b. If existing accommodation is NOT available, German units will be accommodated in temporary camps for which work services will be kept to a minimum. Such camps will be sited if possible away from Allied or Italian troops and the Italian civil population. Due consideration will be given to siting such camps within a reasonable distance of the installation or area in which the Germans are to be employed.

c. If accommodation will be specially requisitioned for German troops, NCR will the better types of domestic accommodation be used where alternatives can be devised, even though such accommodation has been previously requisitioned.

8. GUARDS AND SECURITY.

a. At the discretion of Corps, District or Independent Area commanders, German personnel other than recalcitrants (Appendix 'A') may work unescorted under the supervision of their own senior NCOs.

b. Personnel may be accommodated as stated in paragraph 7 without British or Italian guards. The security of camps and living quarters and the need for perimeter lighting or other special measures will be left to the discretion of the local commander subject to provision of barbed wire fence enclosures equal to not less than triple Darnort.

c. For camps containing over 100 Germans a British security staff will be present always and will consist of:-

7. ACCOMMODATION AND WORK SERVICES.

a. German units may occupy accommodation which has formerly been occupied by Allied or Italian units provided that the local commander is satisfied that such accommodation can be adequately guarded. It is preferable that as far as possible Germans should not be accommodated in close proximity to either Allied or Italian troops.

b. If existing accommodation is not available, German units will be accommodated in temporary camps for which work services will be kept to a minimum. Such camps will be sited if possible away from Allied or Italian troops and the Italian civil population. Due consideration will be given to siting such camps within a reasonable distance of the installation or area in which the Germans are to be employed.

c. No accommodation will be specially requisitioned for German troops, nor will the better types of domestic accommodation be used where alternatives can be devised, even though such accommodation has been previously requisitioned.

8. GUARDS AND SECURITY.

a. At the discretion of Corps, District or Independent Area commanders, German personnel other than resettlees (Appendix 'A') may work unescorted under the supervision of their own senior NCOs.

b. Personnel may be accommodated as stated in paragraph 7 without British or Italian guards. The security of camps and living quarters and the need for perimeter lighting or other special measures will be left to the discretion of the local commander subject to provision of barbed wire fence enclosure equal to not less than triple Dismant.

c. For camps containing over 100 Germans a British security staff will be present always and will consist of:-

- (3) Where it is absolutely imperative for security reasons, to provide an escort for working parties.
 - d. Where there are less than 100 Germans in one group of quarters, the strength of the security staff will be at the discretion of Corps, District or Independent Area Commanders.
 - e. Selected Germans will be used as camp police and will work under the orders of a British Provost Sergeant. Their duties will include patrolling the perimeter of the camp by night and the maintenance of good order at all times within the compound.
 - f. The strictest standard of discipline will be enforced and the senior German Officer in the camp will be held personally responsible for the state of discipline and behaviour of the Germans.
 - g. On no account will German personnel be allowed to mix with the civilian population in streets and living quarters, but this ruling will not affect the employment of German personnel in installations where there are civilian employees.
 - h. At sundown all German personnel other than working parties will be confined to camps or quarters.
 - 1. Over short distances, German personnel will be marched in formed bodies to their place of work. When the distance is too great to march, they will be moved in a formed convoy.
 - j. Vehicles driven by German personnel outside the limits of depots and installations will move in formed convoys with guards in the first and last vehicles. In addition, one guard mounted on a motor cycle will be allotted for each twelve vehicles in the column. When employed within depots or installations, guards are not required. Adequate precautions must be taken under such conditions to ensure adequate general supervision of German personnel.
 - k. Where German personnel are moved by road, the minimum scale of guards will accompany the convoy. If vehicles are driven by Germans, the guards mentioned in paragraph 8j will be required in addition.
 - 1. Recalcitrant German personnel will be guarded as prisoners of war, and adequate precautions will be taken at all times. The exact scale of guards will be largely determined by circumstances and will be left to the discretion

f. The strictest standard of discipline will be enforced and the senior German Officer in the camp will be held personally responsible for the state of discipline and behaviour of the Germans.

g. On no account will German personnel be allowed to mix with the civilian population in streets and living quarters, but this ruling will not affect the employment of German personnel in installations where there are civilian employees.

h. At sundown all German personnel other than working parties will be confined to camps or quarters.

i. Over short distances, German personnel will be marched in formed bodies to their place of work. When the distance is too great to march, they will be moved in a formed convoy.

j. Vehicles driven by German personnel outside the limits of depots and installations will move in formed convoys with guards in the first and last vehicles. In addition, one guard mounted on a motor cycle will be allotted for each twelve vehicles in the column. When employed within depots or installations, guards are not required. Adequate precautions must be taken under such conditions to ensure adequate general supervision of German personnel.

k. Where German personnel are moved by road, the minimum scale of guards will accompany the convoy. If vehicles are driven by Germans, the guards mentioned in paragraph 8j will be required in addition.

l. Recalcitrant German personnel will be guarded as prisoners of war, and adequate precautions will be taken at all times. The exact scale of guards will be largely determined by circumstances and will be left to the discretion of the local commander.

m. Scales of guards required during movement of German personnel by rail are shown in paragraph 6 above.

9. MAINTENANCE, SUPPLIES, MFI, POL

a. Maintenance of surrendered German units and personnel will be the responsibility of the Army, District, or equivalent headquarters in whose area they are located, through the British administrative cadres of units or camps.

b. Where practicable, German units will be employed for maintenance of German troops, but where such units are not available or where there is insufficient justification for separate administrative units, maintenance will be through normal British channels.

c. Rations will be issued to the scale authorized for surrendered enemy personnel plus working element. This scale will be notified to all units carried through S and T channels.

d. Fuel scales will be in accordance with Scale 36 of AFHQ Ration and Fuel Service pamphlet.

e. The scale of toilet articles and necessities will be as at Appendix 12.

f. British administrative cadres will be responsible for supervising the driving of POW from petrol points and will control issues to German-driven vehicles.

10. Entry/Procurement and Documentation Procedure

a. GEC, 2d Echelon will maintain records of personnel in units and will maintain units up to their MB, as from the time of formation of each unit.

b. GEC, 2d Echelon will maintain records of personnel in the base depot and information of the categories available there for employment as from the time when such a base depot is established and organized, i.e., from the time when it is capable of rendering returns to account properly for all individuals held and all arrivals and departures. Pending establishment of a Base Depot, GEC, 2d Echelon will demand reinforcements on Headquarters, No. 1 District.

c. Each unit on formation will render the following to GEC, 2d Echelon.

Subject to the provisions of paragraph c(5) below relating to serious offences officers and WAs (or NCOs and WOs who for any reason are not dealt with summarily under paragraph b(2) above) whose continued presence with the unit is considered detrimental to the maintenance of discipline may be declared to be PW. If it is desired to take this course the facts will be reported to the Brigade, Area or Sub-Area Commander, who, if he decides to make the offender a PW, will arrange for his transfer to the nearest convenient PW camp, and report the action taken to GHQ 2d Echelon. If this course is adopted no other disciplinary action will be taken in respect of the offence, but the offender will thereafter be subject discipline as a PW.

e. Cases involving the following offences committed in ITALY may be tried in Allied Military Government Courts:

- (1) Murder or attempted murder.

f. The following powers of supervision and control may be exercised by the British Officer responsible for the administration of the unit:

Such court will proceed in accordance with the procedure laid down in consolidated instructions for Allied Military Courts, copies of which will be supplied to Commanders concerned.

4. The Brigade, Area or Sub-Area Commander concerned will be required to render all assistance requested by Headquarters Allied Commission. This will normally include the detailing of all workers at the court (other than the president) the prosecuting and defending officers, all arrangements for provision of accommodation and court orderlies and arrangements for attendance of witnesses.

5. In the case of units employed in GUATEMALA, 303 HIGHWAY ARMY will issue separate instructions on the lines of paragraphs 5, 7 and 8 above.

6. The principles of discipline set out above will be made known to all German personnel of units and it will be impressed upon them that if it is found necessary to change their status to that of POW, they will be on the last priority for eventual release and return to their homes.

10. UNIFORMS AND TREATMENT OF GERMAN PERSONNEL

1. Relations Generally:

(1) Relations between British personnel of the employing service, British Centre and British guard personnel and the German officers and GIs of units will be confined to the minimum necessary for the administration of the units and for the performance of work which they are required to do.

(2) There will be no social relations between the British and German personnel. They will be messes and accommodated separately and will not be entertained in each others messes. Any form of sport or recreational activity between British and German personnel is forbidden.

2. (1) There will be no exchange of salutes between German and British personnel. Germans will, however, salute British officers in acknowledgment in receipt of orders and such salutes will be returned.

(2) In lieu of saluting, on other occasions where salutes are ordinarily exchanged between military personnel, Germans will conduct themselves as follows:

1. Officers

If standing they will assume the position of attention when an officer of any of the United Nations Forces enters the room or is in the same room. If seated they will rise and stand to attention. Germans below the rank of officer will conduct themselves in a similar manner in the presence of a member of the military forces of the United Nations below the rank of officer. When conversing on instructions they will uncover and stand to attention.

Relations Generally:

If standing, they will assume the position of attention when an officer of any of the United Nations Military Force approaches or is in their vicinity; if seated, they will rise and stand at attention.

C. MILITARY COURTESIES AMONG GERMANS

- (1) German may continue to render appropriate courtesies to their own officers by rendering the military salute in effect prior to 1933. The Nazi salute and the 'Heil Hitler' greeting are forbidden.
- (2) No German National Anthem or similar military music will be played or sung.
- (3) Military fusarrels for German personnel may be permitted at the discretion of the District Commander under such limitations and with such restrictions as he may deem necessary.
- (4) German personnel may continue to observe and render the same courtesies to their own officers and NCOs as are permitted by their regulations, as herein modified.

d. FLAGS AND EMBLEMS

- (1) When passing an uncut national color or standard of one of the United Nations, Germans will uncover. When being passed by such color or standard, they will stand at attention uncovered.
- (2) Public or private display of Nazi flags and other paraphernalia of the Nazi party or any of its affiliated formations, is prohibited.
- (3) (a) The 'Totenkreuzerchen' and all Nazi insignia, emblems, decorations, or medals will be removed.
 - (b) The 'Kornel' on caps will be removed.
 - (c) 'Wehrmacht' medals and decorations for merit, long service or campaign may be worn, provided all Nazi emblems o.g. Swastikas are obliterated or removed.

17. RELIGIOUS ARRANGEMENTS

- a. Where there are large concentrations of German Surrendered Personnel a tent or tent will be provided for the use of the German factor. Where possible, the accommodation will be so divided as to provide a private office and a quiet room.
- b. Arrangements will be made by the OC of the Unit to which the Factor

(4) German personnel may continue to observe and render the same courtesies to their own officers and NCOs as are permitted by their regulations, as herein modified.

4. FLAGS AND EMBLEMS

(1) When passing an unseized national colour or standard of one of the United Nations, Germans will uncover. When hoists passed by such colour or standard, they will stand at attention uncovered.

(2) Public or private display of Nazi flags and other paraphernalia of the Nazi party or any of its affiliated formations, is prohibited.

(3) (a) The 'Mahnwachen' and all Nazi insignia, emblems, decorations, or medals will be removed.

(b) The 'Kofmo' on caps will be removed.

(c) 'Mohnwacht' medals and decorations for merit, long service or campaign may be worn, provided all Nazi emblems o.s. Swastikas are obliterated or removed.

17. RELIGIOUS ARRANGEMENTS

a. Where there are large concentrations of German Surrendered Personnel a hut or tent will be provided for the use of the German pastor. Where possible, the accommodation will be so divided as to provide a private office and a quiet room.

b. Arrangements will be made by the OC of the Unit to which the Pastor is permanently attached to enable him to visit other German Surrendered Personnel where no Pastor is attached.

18. POSTAL

No arrangements can be made for postal facilities until the postal system has been re-established in Germany. When this has been effected, instructions will be issued further to this paragraph.
