The following is the position regarding reinforcements for the 3rd Bn of the 68 Regt of the Legnano Combat Group, reference to 15 Army Group 5149/5/5(0) of 27 Mar 45.

1. When the Legnano Group was formed from elements of the C.I.L. it was necessary to provide the third Bn for each regiment which had previously had two Bns only. The third Bn of the 68 Regt was formed from the "Arditi" Bn of C.I.L.

2. The War Ministry and the Commander of the Legnano Group were told that it would NOT be possible to ensure that specially selected and trained reinforcements would be available for this Bn, that their organization and duties did not necessitate special personnel and that the sooner this Bn was put on a uniform basis with other Inf Bns the better.

3. In spite of this the Comdr Legnano Group appears still to regard this unit as a special one and to consider the psychological aspect of this question outweighs the more practical one of training/reinforcements.

4. The Rft Trg Centre is not designed to produce special personnel for an "assault" Bn but aims at turning out good infantry for the normal infantry tasks, including assault.

5. It is considered, in view of the infantry role of combat groups and in the interest of economy of reinforcements and the morale of the groups as a whole, that this Bn should be regarded as a straightforward Bn of an Inf Regt.

6. It is strongly recommended therefore that an AFHQ decision be given to regard this Bn as the 3rd Inf Bn of the 68 Inf Regt as originally intended.

7. If this is done there will be no difficulty in keeping the Bn at full HE, otherwise a special training and selection of organization will be needed at the RTC.



1. The reinforcement position of 9 Reparto d'Assalto, 68 Regt Legnano is causing some concern. Although this unit is only showing a net deficiency on posted strength of 44 ORs, this strength on the ground is only 595 ORs as against WE of 738.
