This is in reply to letter No G/104 of April 27, 45.

1. We have taken note of the contents of the above letter concerning the impossibility of using - this year - Army personnel in harvesting and threshing operations.
2. The measures already adopted for the release of the earlier classes (1913 and previous ones - last four months period of 1914) will undoubtedly contribute to alleviate the crisis which threatened - and is still threatening - in some areas due to a shortage of local labour, but will not suffice to avert it altogether.
3. In the FOGGIA area and in the provinces of MATERA, for example, during the height of harvesting and threshing operations (beginning of June - middle of July) there are needed about 10,000 and 12,000 workers respectively, over and above the ^{amount} of local labour.
4. The Ministries of Agriculture and Forestry and of Industry, Commerce and Labour are all ready taking steps to deal with this grave crisis in accordance with the limited means at their disposal.
5. A measure which would contribute to solve the problem would seem to be that of organizing in the provinces of FOGGIA and MATERA a reserve of 3,000 German P.W.s properly selected and placed under the command of Italian personnel, to be employed in the event of a labour shortage.
6. Please inform me of the decision - which I am kindly asking your Sub - Com to take without delay - concerning this important and vital matter.

With reference to your letter SM 6673 dated 6th April 1946, information has been received that of the 100 ratings at Taranto only 55 have been found suitable for utilizing as reinforcements for No. 1 (Italian) I.W.T. Company and arrangements are in hand for these men to join the Company in Bari as soon as transport is available.

2. The undermentioned deficiencies in (Italian) I.W.T. Companies could not be filled from the Taranto watermen and special provision action will therefore be necessary.

3. Two of the 4 officers from Taranto are suitable for transfer to I.W.T. Captain Toller Enzo is fitted for command of No. 1 (Italian) I.W.T. Company, while Sub/Lt. Gresso Nicolo might replace Sub/Lt. Chiappori of No. 3 (Italian) I.W.T. Company.

4. It is requested therefore that action be taken to effect the transfer of these two officers as early as possible and to obtain the specialist reinforcements still required to bring Nos. 1 and 3 Companies up to a reasonable state of efficiency.

4. In the event of your application being granted and the detachment authorised, I can probably arrange for the existing personnel to be posted to it.
