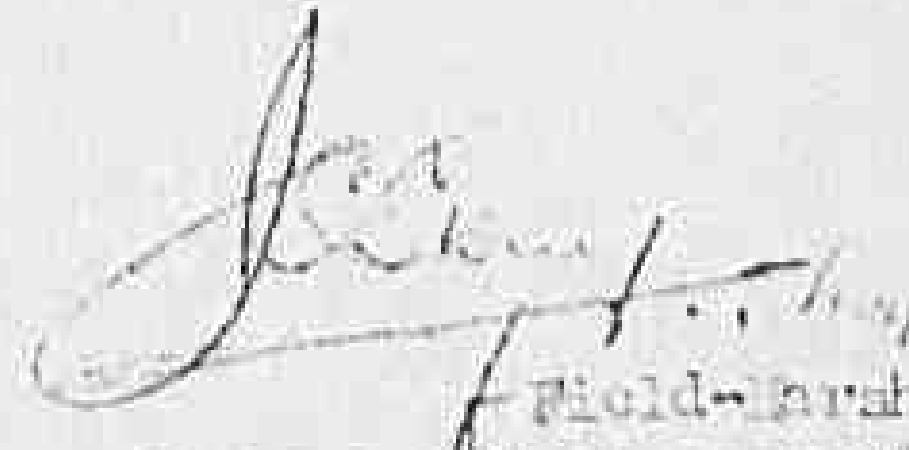

1. In MEIA SD/35 of 12 May orders were given for 541 Infantry Regiment to be disbanded and personnel disposed of under year arrangements.

2. In their signal 332/117 of 19 May to 227 Div and 3 Territorial M.Q. S.M.R.E gave instructions for the other ranks to be sent to PRUSINORE. Disposal instructions for the officers were to be given by the Ministry of War.

3. These instructions have apparently not yet been given with the result that the officers - 17 in number - will be left in the ORTOMA area, attached for rations to some other unit, and surplus to M.E. as from the date of disbandment, 30 May 1946.

4. In such cases there is no reason why officers as well as OR's should not be sent to Reinforcement Depots. They are in fact constantly in demand from such depots both as replacements and for the formation of new units. Please ensure therefore:

(a) that instructions are given immediately with regard to the disposal of the 17 officers mentioned above.

(b) that when units are disbanded in the future, instructions for the disposal of officers are given at the same time as those for OR's, if necessary sending them to Reinforcement Depots of the appropriate category until further postings are made.
