To :- Ministry of War.

1. This H.Q. has been requested by 2 R.L.U. GENOA to approach you in the matter of obtaining the services of a rather more highly qualified officer as their Italian Liaison Officer than the present one.

2. Their reasons for making this request are as follows -

- (a) Although the present LO with the Unit (Ten. ZIMMIG) is always anxious and willing to help, his knowledge of English and experience in liaison duties are not considered really adequate to the requirements of this appointment.
- (b) It is considered that this appointment requires an officer of rank senior to that of Lieutenant, as his duties very often bring him into contact with senior officers of the Italian Army. An officer of Lieutenants rank is rather too junior to carry weight with such senior officers.
3. It would be greatly appreciated if you could see your way to posting an officer fulfilling the above listed requirements in place of the present holder of this appointment. 2 R.L.U. have emphasised that this request for a change in no way reflects on the character of Ten. ZIMMIG, who has worked hard and rendered good service to 2 R.L.U. It is only that he is not considered to have all the qualifications necessary in this particular appointment - no fault of his.
