I'm old and my husband is an invalid of world 1st war 60 year old and heartsick, too. But in spite of that said Commission, which is still composed by big fascists who have been griefstricken by Mussolini's death, did not care of my son. For this reason and for many other reasons we'd like that people like that of our Town Hall should be expelled .

As I trust on you I'm begging of you to do something against them because my son is entitled to that prize and there no reason he can be left out.

1. This HQ has been informed by the Finance Sub-Commission of the Allied Commission that there is no authority for any Allied Finance Agency to effect the exchange of Allied marks and Reichs marks in possession of Italian military, into Italian lire. This exchange is purely a matter of Italian administration and the necessary arrangements must be made through the Ministry of Treasury. A statement made by the above named officer is therefore returned herewith for your action.

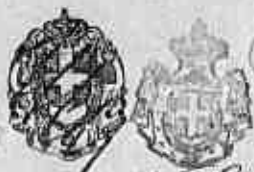
