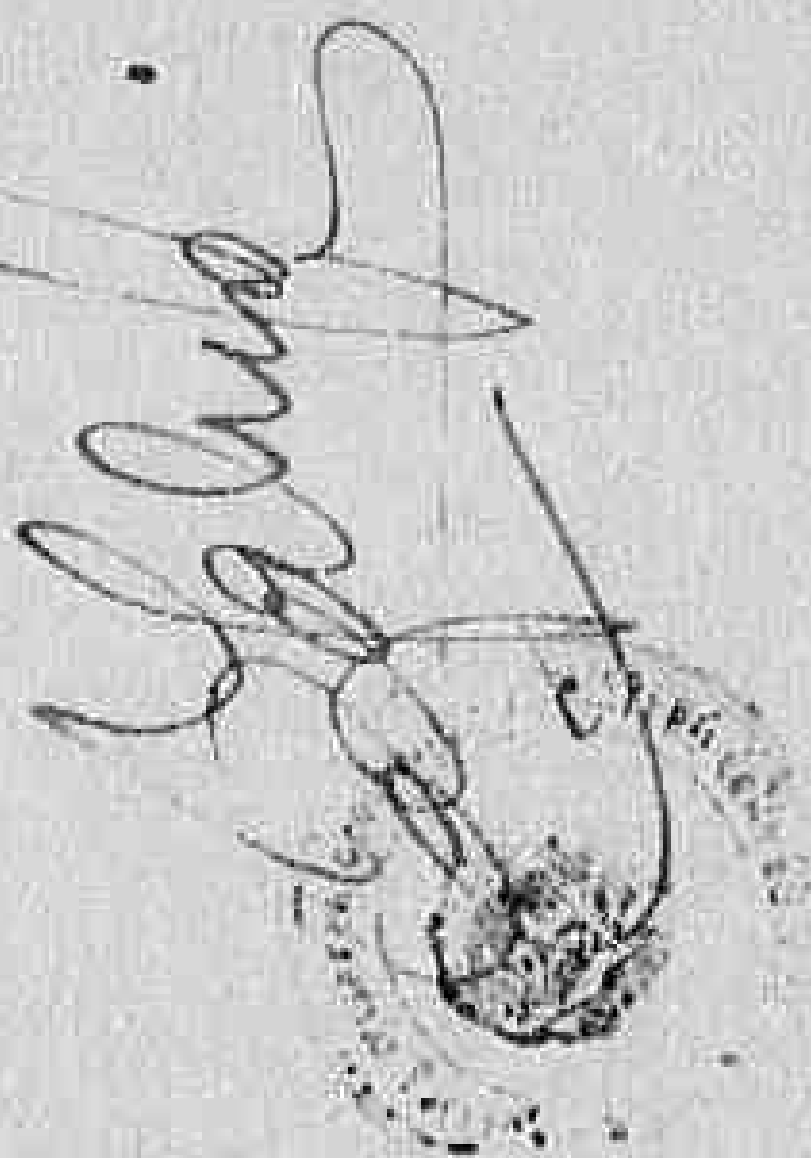

Reference your Communication of 11 July 45 and 227 Divisional Commander's request I submit herewith report on a/n Officer.

a) During his command the Company was of a low standard, its general bearing and discipline leaving much to be desired, judged from any military viewpoint. Complaints on the Company's work by Employing

Services were frequent, and though men were punished in individual cases, they were on more than one occasion upheld and vindicated when a number was involved and this despite their being quite obviously at fault. Theft and pilfering while at work had assumed quite large proportions, and necessitated the adoption of guards to check it.

Internal routine administration was good, but control and command was lax and lacked that personal effort to check and correct serious faults and tendencies, before they became actual crimes.

b) As regards this Officer's capacity to Command I do not hesitate to state that I think he is quite capable, and that he knows his job and could do it well if only he had the intention.

But he had a complex which seemed to resent British Control however remote and tended to view any suggestion or request made by British Cadre as interference in his rights of command.

In consequence there was a minimum of true co-operation and an under-current of resentment continuously barring the way to progress and improvement.

It was for this reason that I asked that he should not be returned to this Company, whose conditions had become worse, and so bad that a completely new command, and vigorous corrective policy was absolutely essential.

Only a first class man willing to co-operate and unwilling of his own accord to tolerate bad and

Only a first class man willing to co-operate and unwilling of his own accord to tolerate bad principle and irresponsibility in any form, is capable of making the necessary changes and of bringing about an efficient and satisfactory standard.

In the new O.C. recently posted to this Unit I do feel that I have such a man, and already a very marked improvement has been achieved.

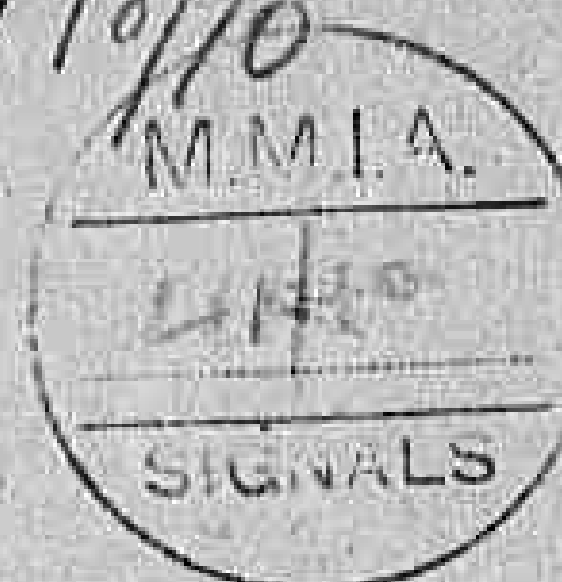

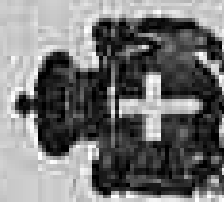
