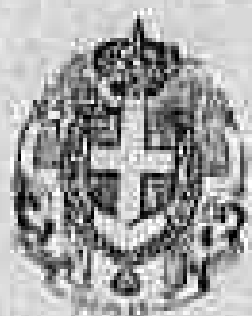

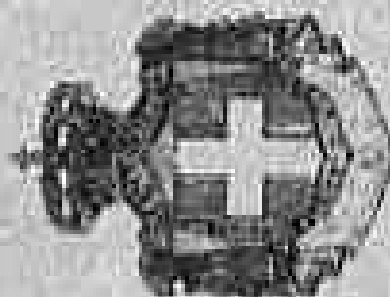

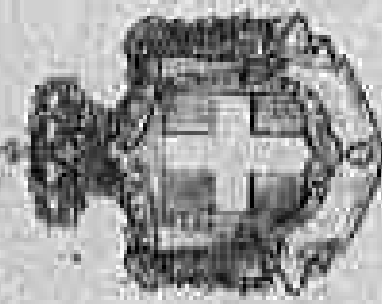

2. The position of a/m Dr. seems to be somewhat obscure, and in order to clarify the situation M.M.I.A. are making enquiries.
3. Your letter Ref. Sec/Op/10/2 dated 14 April 1945 encloses Dr. Gigli's application for release.
4. In his applications, he states that he is no longer P.W. since returning to Italy and was informed of this by a letter from "this" H.Q. last October. It is not quite clear which H.Q. he means.
5. As there is no record at this H.Q., or with M.M.I.A., regarding this statement, our letter ref. DPR/PP/A dated 5 May 1945 was sent to you requesting copy of the authority.
6. As no reply was received from you, a hastener same ref dated 9 June was forwarded, and again on 5 July with same negative result.
7. It is suggested that pending reply from M.M.I.A. as to the status of Dr. Gigli, he is considered P.O.W. and is treated accordingly for his rations and other privileges.
