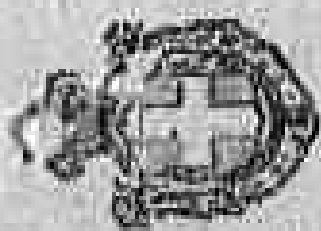

2. It is suggested that Col. Dal Fiume's successor should report not to this Headquarters but to the Headquarters of the 820 Italian Searchlight Battalion, since the handover is of purely Italian concern.

3. It is once more pointed out however that the Artillery section, A.F.H.Q. should also be consulted before Dal Fiume is released since they were associated with this Headquarters in the Colonel's appointment as Commander of the 820 Searchlight Battalion which comprises four platoons working for the British Army.

4. While on the subject of Col. Dal Fiume, a copy of the letter from the Comando Militare Territoriale di Napoli is attached. This is the second letter received from that Headquarters, and is contrary to the existing practice whereby all instructions, requests etc. between the Italian authorities and ourselves are to be communicated to you. No reply has been sent to the Comando Militare and it would be appreciated if a suitable reply were sent to them.

2. This Headquarters has not, in principle, any objection now to the release of Col. Dal Fiume.

3. Colonel Dal Fiume is however very busy just now arranging for supplies of stores and equipment to be available for use during the winter months. He is also endeavouring to obtain personnel to replace the many trained searchlight operators who have recently been released by the Italian Army. This work should all be finished by the beginning of September and Colonel Dal Fiume's services could be dispensed with as from the 1st of that month.

4. It will;be necessary however to retain some kind of set-up after Dal Fiume has gone to administer the searchlight detachments and to be responsible for the operational efficiency of the equipment. It is suggested, therefore, that an Italian Army Searchlight Officer be appointed immediately to serve under Dal Fiume for the next weeks until he takes over command; this Officer should not only know searchlight work but also should have some knowledge of English.

5. Finally, it should be pointed out to the M.M.I.A. that Dal Fiume's appointment does not only depend on M.A.A.F. but also on A.F.H.Q. since he is also responsible for some searchlight platoons which are working for the Army.

2. The originator of the above quoted letter may not be aware of the current Italian regulations as regards the release of Reserve Officers. A copy of a letter from MMIA to A.F.H.Q. (2) reference A.302 of the 11th July 1945 is, therefore, forwarded for your information, and so far as possible it would be appreciated if the policy contained in that letter could be complied with.

3. In the particular case of COL. DAL FUME, it is requested that the matter be reconsidered with a view to allowing the Italian War Ministry to retire COL. DAL FUME, unless his services are absolutely essential to the Allies.
