

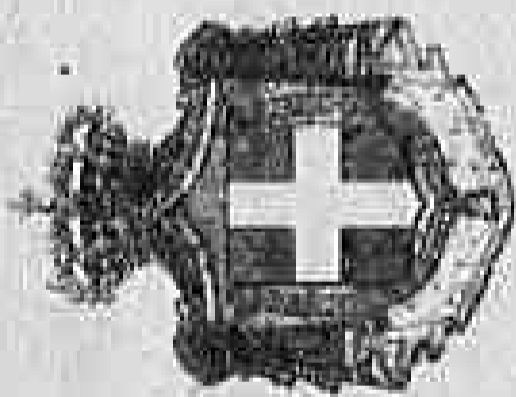

The delay in obtaining answers from the Ministry of War to letters from M.M.I.A. in certain subjects has recently become very noticeable.

The subjects in question are usually enquiries concerning the postings of officers, and enquiries concerning the identity and whereabouts of certain officers and ex officers.

In one case which occurred recently, following repeated requests for an explanation as to why the Ministry of War wished to post an officer away from Naples, the patience of M.M.I.A. clearly became exhausted and orders were given to cancel the Ministry of War posting without waiting any longer for the explanation.

This may happen again, and it is considered that the Ministry of War would be well advised in their own interests, to examine the personnel and machinery in those branches of the Ministry of War that deal with these subjects, with view to taking some drastic action to speed up replies to enquiries, on these matters.

SUBJECT: Genio Militare, Location of Offices

TO: The Army Engineer


1. Paragraph 3d of MTOUSA Letter, subject, Procedure for Requisitioning, Operating and Payment for Hotels and Restaurants Operated by Civilian Owners or Managers; AG 004/654 ENGR-O, date 29 April 1945 states that except on matters concerning requisitioning, using organizations will deal directly with the Comando Genio Militare, which is the Italian Military Engineer Command.
2. In addition to the above procedure, the Genio Militare assumes other responsibilities concerning compensation to civilian property owners.
3. At the present time Military Managers of hotels now in operation from the Ligurian coastal sector across to the inter-army boundary are experiencing difficulty in contacting agents of the Genio Militare so that civilian managers can obtain operating expenses.
4. In addition to the hotel question, other property owners are dissatisfied with the apparent lack of attention their claims for payment are getting from the Genio Militare.
5. The difficulty in the past has been lack of personnel available for assignment as Genio agents to small sub-divisions in the Italian areas. More agencies ^{is} ~~are~~ imperative.

(Genio Militare, Location of Offices, con't)

6. Besides the territorial agents required I believe that a representative in each Army Real Estate Office to operate thru the sub-division agents would be desirable. One well qualified Genio Militare Officer with the Main Army Real Estate Office should be the barest minimum acceptable if this condition is to be corrected.

7. Political implications arising from thousands of dissatisfied owners of properties occupied by US and Allied troops can not, I believe, be considered lightly even though tardiness in the settlements to these owners may be caused by circumstances beyond control of the Commando Genio Militare.

8. It is suggested that US and Italian authorities concerned take immediate steps to remedy this situation.

1. Under present directives the term "civilian" includes all Italian nationals not now on the active list of the Italian Armed Forces regardless of any prior service in the Italian Armed Forces. Reserve officers, not on active duty as a member of the Italian Armed Forces within the authorized order of battle, are therefore termed civilians.
2. No member of the active Italian Army, now carried on the order of battle within the authorized ceiling, may be employed on any duty other than that shown on the order of battle. Where it is desired to employ an officer (regular or reserve) now on active duty, it will be necessary to remove such officer from the strength returns of the Italian Army; and such Italian law as operates to retain the officer on the reserve of the Italian Army, on inactive status, will take effect.
