I have just learned from my wife, Colomba, residing at Brocco, Province of Frosinone, that our son, Lt. Alberto Farina, was killed about three or four months ago in Italy under mysterious circumstances.

He was in the Italian Army and fought against Germany having made several raids on Germany with his parachute unit. He was twice a prisoner of war in Germany and made two escapes.

I know that my son had no sympathy for Fascism or Nazism.

As a proud American citizen, I am appealing to you to obtain the details on the case of his death, and communicate the same to me.

I shall be very grateful to you if you would enlighten me on the case of the death of my said son.
