Army Order Number 48 of 1945 is repeated herewith for information :

"SCHEDULE

As a war time measure, officers on the Active List of the Territorial Army may be given substantive promotion as follows :-

Regimental Officers

- (a) To Lieutenant, Captain, Major and Lieutenant-colonel, after 3 years', 8 years', 17 years' and 22 years' total service respectively, provided that an aggregate of not less than 12 months' full time satisfactory service has been given during that time, in the same or a higher paid acting or temporary rank.

Departmental Officers

- (b) Substantive promotion after specified periods of service, as provided in Territorial Army Regulations, will be restored, subject to the modification that attainment of the equivalent temporary or war substantive rank will be accepted in lieu of the normal promotion qualifications.

Colonels

- (c) To Colonel by selection, within a fixed establishment, from among officers who have rendered long and meritorious service in the Territorial Army, and who -
  - (i) have held paid acting or temporary rank of Colonel, or above ;
  - (ii) are substantive or war substantive Lieutenant-colonels;
  - (iii) have completed an aggregate of 3 years' service in appointments carrying the rank of Lieutenant-colonel, or above.

General Officers

- (d) To General Officer by special selection by the Secretary of State from among officers who have rendered long and meritorious service in the Territorial Army, and who -
  - (i) have held as paid acting or temporary rank, the rank to which they are being promoted;
  - (ii) hold the substantive or war-substantive rank immediately below that rank;
  - (iii) have completed an aggregate of 3 years' service in appointments

Regimental Officers

(a) To Lieutenant, Captain, Major and Lieutenant-colonel, after 3 years', 8 years', 17 years' and 22 years' total service respectively, provided that an aggregate of not less than 12 months' full time satisfactory service has been given during that time, in the case of a higher paid acting or temporary rank.

Departmental Officers

(b) Substantive promotion after specified periods of service, as provided in Territorial Army Regulations, will be restored, subject to the modification that attainment of the equivalent temporary or war substantive rank will be accepted in lieu of the normal promotion qualifications.

Colonels

(c) To Colonel by selection, within a fixed establishment, from among officers who have rendered long and meritorious service in the Territorial Army, and who -  
(i) have held paid acting or temporary rank of Colonel, or above ;  
(ii) are substantive or war substantive Lieutenant-colonels;  
(iii) have completed an aggregate of 3 years' service in appointments carrying the rank of Lieutenant-colonel, or above.

General Officers

(d) To General Officer by special selection by the Secretary of State from among officers who have rendered long and meritorious service in the Territorial Army, and who -  
(i) have held as paid acting or temporary rank, the rank to which they are being promoted;  
(ii) hold the substantive or war-substantive rank immediately below that rank;  
(iii) have completed an aggregate of 3 years' service in appointments carrying, at least, the rank immediately below that to which they are being promoted.

Quarter-masters

(e) To Captain and Major after 6 years' and 12 years' commissioned service, respectively.  
To Lieutenant-colonel by special selection from among Quarter-masters who have rendered not less than 25 years' commissioned service in the Territorial Army during peace and war, and have rendered exceptionally distinguished or meritorious service as Quarter-masters during the present emergency.

Reckonable Service

- (f) Service reckonable as total service under (a) above will except as provided below, be continuous commissioned service in the Territorial Army only. Periods spent in the Territorial Army Reserve of Officers will not reckon, but broken Active List service may be aggregated where the whole of the intervening period has been spent in the Territorial Army Reserve of Officers.
- Service in the ranks of the Territorial Army is reckonable towards total service under (a) as follows provided it is continuous with Territorial Army commissioned service:-
- Service as warrant officer, Class I ..... in full
- Service in lower ranks ..... as half
- Unpaid commissioned service during the war will not reckon either towards total service or towards the qualifying period in the rank.

## ARMY COUNCIL'S INSTRUCTIONS ON THE FOREGOING ORDER

1. The establishment of Colonels will consist of 120 officers, of whom 20 will be medical officers. Any necessary Railway Staff Corps appointments will be additional to this establishment. Officers on the colonels list who have been unemployed throughout the war and those admitted to the establishment who revert to unemployment in future will be transferred to a supernumerary list.





1. During a recent visit of His Excellency the Governor of Malta to Italy, where he met Maltese liaison officers serving with Italian Combat Groups, it transpired that these officers were being employed in ways contrary to the terms on which they volunteered for service.

2. The individuals concerned are combatant officers who have in some cases relinquished active command of artillery regiments, batteries and infantry companies in MALTA, in order to offer their services in Italy. They are valuable men who can ill be spared for work other than that originally specified by H.Q., A.M.

3. It is essential that immediate steps be taken to employ these officers in their proper role as liaison officers and that every facility be offered to them to enable them to function to the limit of their capacity.

4. It is desired that the senior officer of the group, Major H. 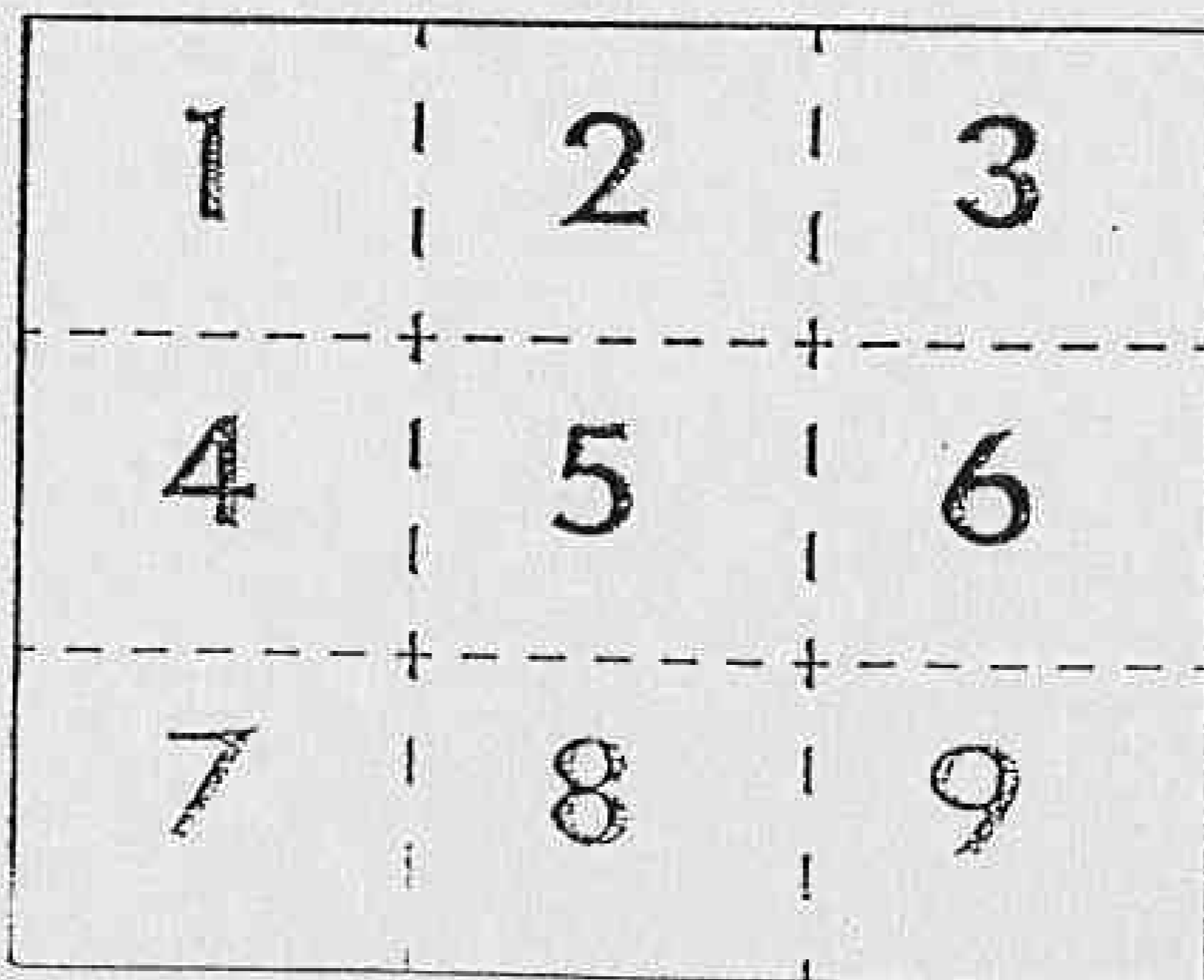
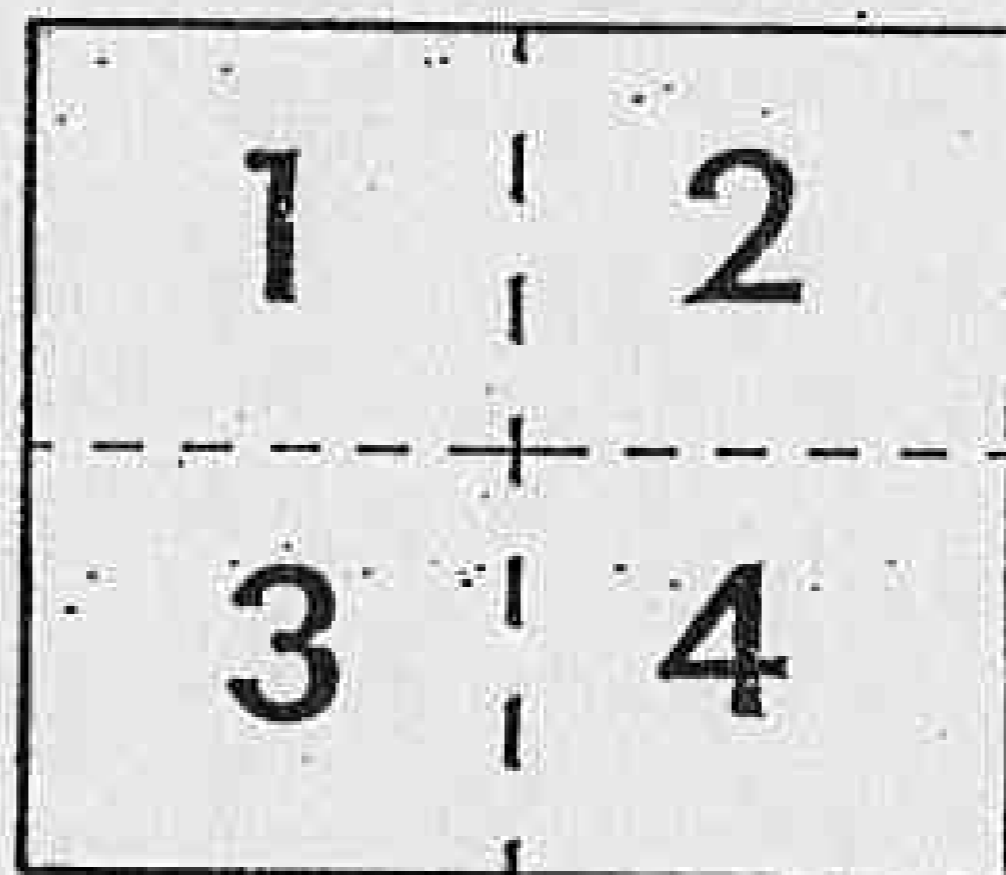
