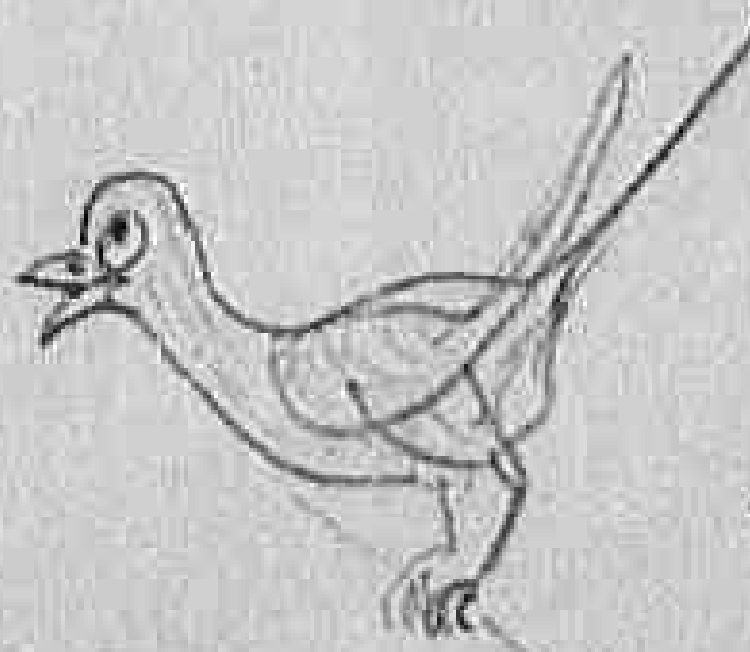

5. A charge of 7/6d per month will be made for each Broadcast Receiver hired. Units will raise this hire charge monthly in the form of a debit voucher, quoting the number of WEL/TEAM Release, from the attached release note. The first debit voucher will be raised on the date on which the Receiver is drawn from DADOS Dump 59 AREA, and the first payment of 7/6d will be made in advance by the holder.
6. Should holder of Broadcast Receiver be posted to another unit in CME, taking his family with him, the receiver may be taken, being voucher raised from his old unit to his new unit. New unit becomes responsible for raising debit voucher each month.
7. Should holder leave CME or send his family home, broadcast receiver will be handed in. Unit will give the holder a certificate that the set has been handed in in good condition, with all charges paid up to date, and the hiring agreement thus terminated. Units are then responsible for returning the receiver to DADOS Dump, and for Part X-ing it off unit charge. A copy of this Part X certificate will be sent to original holders.
8. All repairs and renewals to Welfare Broadcast Receivers, due to fair wear and tear will be done by REME, free of charge.
