1. Enquiries reveal that 686 Inf Troops Workshops HEMM was disbanded in July. It is therefore not possible to obtain either the watch or a BLR certificate.
2. It is considered that the 76 Inf Regt should have brought this matter up previously. Six months have elapsed since they handed this watch in for repairs.
3. If a unit hands any item in to any workshops for repair and that item is not returned in a reasonable time, c.e. two weeks, it is the duty of the unit to enquire and find out why the necessary repairs have not been completed or a BLR certificate forwarded.

1. It is highly irregular for an Infantry Regiment to set up its own workshops, and destroys the organization provided by the WE for the repair of the equipment of the division.
2. The only personnel capable of supervising the repair of watches are in the Divisional Workshops. On no account should regiments be allowed to tamper with watches as they have no personnel who are capable of judging whether the repairs are being carried out adequately or not.
3. It is therefore requested that these personnel employed by 76 Regt should be transferred to the Divisional workshops with their tools, trade tested and if found suitable employed there.
