1. Italian Provided Items existent in British RASC Depots have not been charged, financially, to the British Government.
2. These items have been purchased by the Ministry of War, transferred at British bases (normally 14 or 22 CRASC NAPLES or BARI) and transported through RASC channels to British RASC DID's for distribution to units of the Italian Armed Forces.
3. The only accounting required at the time of handover is an inter-depot transfer. No financial transfer is involved.
4. One exception to the above may be in the case of purchase of wine by RASC agencies; however, this purchase is charged to the Italian Government by AFG 1680.

- (1) Reference this office letter STG/23 dated 7 August 45 and your letter ST/256 of 16 August 45.
- (2) Your remarks are not entirely understood as No ST/3 has been made for this. Insufficient stocks of empty barrels were available at this time, to exchange for full ones; accordingly these were included on the receipt. When returned, the contra receipt will automatically cancel out this item. Local Commissariate Genoa have been notified that any of these particular barrels not returned will be chargeable to the Italian Government (STG/16/2 dated 2 August 45, copy to your Hq.).
- (3) It is considered that it would be advisable that a copy of AFG 1033's for stocks of Italian Elements of the ration handed over from British Depots to Italian Depots should be held by Accounts Branch. According to information received from 42 B.S.D. and 2 District these stocks have already been charged on AF's G 1680 to the Italian Government; and these AF's G 1033 therefore relate to the actual quantities transferred as balances remaining, after issues made by British DID's against ST/8's on behalf of the Italian Government were completed.
- (4) Verifications of these balances handed over can thus be made by Accounts Branch and any necessary adjustments made.
- (5) It is pointed out that ST/3's have only been raised in respect of transfers of Allied provided items of the ration.
- (6) Copies of AF's G 1033 Nos.1,2,3 are therefore returned to you.
