- 1)- should not comply with requests for food-rations to Italian personnel employed by Allied Departments without previous authorization granted by the M.M.I.A., even if aforesaid requests are solicited by Allied Departments;
- 2)- should arrange for the withdrawal of all bilingual posters put at the entrances of all houses occupied by dependent military departments, excepting the poster fixed at the entrance of Patrone Building (residence of this Command).

TO: Territorial Military Headquarters of Genoa.

1. Capt. MORDIGLIA Aldo has been attached to the Legal Office, Liguria Region, A. M. G., since the first week of May 1945. He was requested by this Headquarters and subsequently released from the Legnano Combat Group.

2. Headquarters Legnano Group have informed Capt. Mordiglia that on the 31 May 1945 he was transferred to the Territorial Headquarters of Genoa, and on the 2nd June 1945 a letter on the above subject was sent to your Headquarters, copy to the Ministry of War for regularisation of the transfer.

3. Since 1 May 1945, Capt. Mordiglia has not drawn any pay or rations.

4. This Headquarters will apply directly to the Ministry of War in order to regularise the transfer of Capt. Mordiglia. Meanwhile, would it not be possible for you to attach Capt. Mordiglia to your organization for rations, pending official sanction from the Ministry of War?

5. Inclosed please find letter from the Legnano Combat Group (Ufficio Personale) addressed to Capt. Mordiglia.
