MAINTENANCE M.F. ITALY

INSTRUCTION No. 1

INTENTION

- (1) 2 Deposito Speciale Genoa will move to Milan and occupy premises allotted to them at Magazzini Generali. Move to be completed by 10th Nov.
- (2) 2 Deposito Viveri Genoa will occupy premises vacated by 2 Deposito Speciale and will be ready to issue supplies on the 21 Nov.

METHOD

- (1) Commissariato Genoa in conjunction with OG 2 Deposito Speciale will arrange to transfer immediately a proportion of the Depot personnel to Milan to prepare Depot and to receive stocks. Commissariato Milan will arrange suitable billets, guards, etc.
- (2) Commissariato Milan will ensure that stocks of 3 Deposito Viveri at present held in Magazzini Generali are moved immediately to Via Montal, 59.--
- (3) In order to prevent unnecessary handling of supplies Commissariato Genoa will arrange the despatch immediately of supplies (15 days) intended for maintenance period 6-20 Nov. based on the undermentioned figures:

PLACENZA	9,000
TURIN	15,000

(2) 2 Deposito Viveri Genoa will occupy premises vacated by 2 Deposito Speciale and will be ready to issue supplies on the 21 Nov.

METHOD

(1) Commissariato Genoa in conjunction with CC 2 Deposito Speciale will arrange to transfer immediately a proportion of the Depot personnel to Milan to prepare Depot and to receive stocks. Commissariato Milan will arrange suitable billets, guards, etc.

(2) Commissariato Milan will ensure that stocks of 3 Deposito Viveri at present held in Magazzini Generali are moved immediately to Via Mont4, 59.-

(3) In order to prevent unnecessary handling of Supplies Commissariato Genoa will arrange the despatch immediately of supplies (15 days) intended for maintenance period 6-20 Nov. based on the undermentioned figures:

MILAN	23,000
PLACENZA	9,000
GENOA	15,000

Commissariato Genoa will submit program to this office for approval.

(4) CC 2 Deposito Speciale will hand over to CC 2 Deposito Viveri in location 13,000 x 10 balanced rations being maintenance for period 21 Oct - 5 Nov not completed and maintenance for period 6-20 Nov. referred to in para 3 above.

(5) Stocks remaining after carrying out instructions in para 3 and 4 above will be despatched to new Deposito Speciale Milan.

(6) Major 66 will arrange direct with Italian Railway Authorities for the re-direction of wagons ex 13 ONASO (Supply Units) to Milan as required.

ADMINISTRATION

(1) Major Ge will co-ordinate all movements of personnel, stocks, etc and any difficulty resulting therefrom will be referred direct to him. Major Ge will keep this office informed of his daily movements.

(2) All Commissariati will submit to this office Stock States as at 10 Nov 45 for depots under their command, ensuring that stocks in transit (if any) are included in Stock States of receiving depots.
