

To :-

1. The apprehended VD pro-forma is forwarded to you for necessary action in accordance with arrangements made with the Medical Authorities 217 Area.

Upon receipt of this pro-forma you should :-

- (a) Cause immediate contact to be made with the local Questura (or CC.RR.) who will be requested to apprehend the woman; escort her to the civil hospital, and, if found to be infected, submit a written complaint to the Questura (or CC.RR.) requesting them to prefer charges in terms of the civil law.
 - (b) The Questura (or CC.RR.) will then take all necessary action against the woman; cause her to be detained in hospital, and ensure that civil Police action is instituted.
 - (c) Give every assistance to the Questura (or CC.RR.) as regards Interpretation, transport etc. while carrying out their duties.
2. The necessity for action by Unit Commanders in these matters is caused by the fact that Provost resources are now very limited whilst reported cases of VD are on the increase. It will be appreciated that it is MOST ESSENTIAL that there should be NO DELAY in investigation of these reports and apprehension of the women.

Commanders will ensure that the provisions of SARO 190 dated 26 Dec 45 are strictly enforced and that severe disciplinary action is taken against men who fail to make use of the facilities provided.

The PaC and unit E.T. rooms will be inspected by the comda concerned to ensure that they are fully equipped and conveniently situated. It is very important that clear instructions are posted on the walls of E.T. rooms on how to take the necessary precautions against V.D., and it must be impressed on the men by means of lectures by officers, the desirability of avoiding contact, or failing this, of taking the most thorough and careful precautions; these precautions are effective if properly used and no time is lost after exposure.
