Subject : P's OW at LATERINA Camp

To : M.H.I.A.

1. Information has been received from 7 Territorial Command that 796 P's OW are held in LATERINA Camp. These are all ex Germany Army personnel from the ALTO ADIGE District.
2. It is reported that they cannot be liberated without Allied Military authority. It is further reported that Allied sources are informing the relatives of these prisoners that the onus for sanctioning their release is on the Italian authorities. This situation is giving rise to much dissatisfaction at the Camp.
3. Will you please notify this HQ. of who is responsible for granting the release of these personnel and of any information available as regards their eventual release.
4. Please treat as urgent.
