1. During the Inspections which I have carried out of various Installations within your Command I observed that there is an acute shortage in the supply of adequate Fire Fighting Equipment.

2. I have taken up this matter with H.Q. M.M.I.A. and asked them to release further supplies through your Ministry of Supply.

3. In order that I may add greater strength to my demand on M.M.I.A. I would request that you arrange for a complete Census to be taken, in all units of 7 Terr. Command, of (a) : all Fire Fighting Equipment now held and also (b) : what Equipment is still required. It would be appreciated if the two Lists - (a) and (b) could be forwarded to me as soon as practicable.

4. I would suggest that the Lists (a) and (b) be prepared on the lines of the Specimens as attached, the types of Equipment, of course, being according to your requirements.
