General Remarks:

1. This is a unit which is doing a good piece of work in handling the barrage balloons in and around Leghorn, but needs attention both from the Allied and Italian sides for the unit lacks proper clothing, shoes, and also rations do not appear adequate for the heavy work these men are doing in raising, lowering and handling the balloons. There appears to be a definite insufficiency of the Italian components of the ration. Capt. Dadini (Italian) is supposed to be the Italian L.O. for this unit at Leghorn and for the one at Ancona which is also under command of Sqd. Leader Woods, but Dadini has not been heard from in months. It is rumored he is in jail, having been picked up by the British M.Ps. near Taranto. In any event, Woods says he is no use to him and should be replaced. He also states that S.M.R.E. has sent Lt. Rosetti to relieve Lt. Tempesti at Ancona, but he does not approve of this transfer for Tempesti is performing his work satisfactorily.

2. Reference paragraphs 4 and 5 basic communication, all personnel present were listed on nominal roll attached as appendix "A" except those on appendix "B" attached. In accordance with your instructions, I have given orders for the men listed on "B" and not on the original nominal roll to be sent to TRANI, attached is copy of my letter to Squadron Leader Woods. Attached as appendix "C" is the list of men now present with the company, including those which are shown on "B" and are to be sent to TRANI. The effective strength of the unit after the officer and the men named leave for TRANI will be 4 officers and 149 enlisted men available for transfer to the Italian Air Corps.
