I. - E' nota a cotesto B.L.U. la disagiata situazione di accasermamento e sistemazione degli uffici del distretto di Roma, frazionato in tre vecchi edifici, i cui locali angusti e ristretti mal si adattano al funzionamento di un comando quale quello del distretto di Roma, congestionato da un lavoro pressante e quanto mai complesso.

Nel quadro della sistemazione degli enti militari di Roma è previsto il trasferimento all'ex caserma Mussolini di tutti gli uffici del distretto e di altri enti militari della Capitale.

Con tale trasferimento si renderebbero disponibili, per la cessione al Ministero dell'Assistenza Post-Bellica, le seguenti caserme ed occupate attualmente dal distretto :

- caserma Giacomo Medici - Via Paolina,
- " Rosselli - Via Paolina,
- " Lamarmora - via S. Francesco a Ripa.

Tali edifici, qualora destinati, come previsto, agli sfollati che attualmente occupano le palazzine della Cecchignola, consentirebbero la completa disponibilità per uso militare della Città militare della Cecchignola ed eviterebbero il frammischiamento che - per evidenti ragioni di disciplina e di funzionamento delle scuole ivi sistemate - è assolutamente

te necessario di eliminare.

II.- Questo comando ha già avuto, via breve e da tempo, notizia che l'ex caserma Mussolini - attualmente occupata da truppe francesi - sarebbe stata restituita all'amministrazione militare italiana.

Trattasi di un edificio confortevole e funzionale su tre piani e con numerosi locali uso ufficio e camerate, per un complesso di circa 250 vani e per una capacità di ricovero truppa di circa 2.500 uomini.

Attualmente è occupata da truppe francesi per un complesso di circa 250 - 300 uomini.

Poichè si rende necessario, per i motivi su esposti, un'urgente sistemazione del distretto ed il conseguente sgombero degli sfollati dalla Cecchignola, prego cotesto B.L.U. volere interessare la M.M.I.A. per la restituzione della suddetta caserma e, ove esigenze di carattere superiore richiedessero la permanenza in Roma della Missione militare francese, esaminare la possibilità di trasferirla in altro edificio idoneo alle necessità della Missione stessa.

SUBJECT: Accommodation of units and H.Q.s in Rome

1. - Gradual accommodation of 6000 displaced persons

The gradual accommodation of 6000 displaced persons could be effected by the handing over of the of the following barracks of the Military Administration, at present being used by units and H.Q.s in the capital :

- Roselli barracks
- Giacomo Medici barracks
- Lamarmora barracks (already partly occupied by displaced persons and handed over for use as storage to U.N.R.R.A.)

The above mentioned handing over is, however, conditional upon the return to the Military Administration of the following barracks :

formerly Mussolini barracks = at present at the disposal of Allied troops, and in which would have to be accommodated :

- district H.Q. and various units which at present occupy the Roselli and Giacomo Medici barracks;

C.R.E.M. barracks = formerly H.Q. of naval units and at present at the disposal of Allied troops (American hospital). The units of the Navy which are at present occupying the Principe di Napoli barracks would have to return to these barracks.

Principe di Napoli barracks = at present occupied by the Navy which upon obtaining the return of the C.R.E.M. barracks could make it available for the units in Rome which are at present very badly accommodated in the premises at our disposal.

2. - Accommodation of the territorial H.Q. and directorates and units under command.

As is known, the territorial H.Q., directorates, and offices under command, are at present accommodated in buildings or on premises which have been requisitioned from private owners, which, besides causing considerable expense to the Exchequer, are constantly having their return requested, in view of the fact that their occupation cuts considerably into the recommencing and reconstruction of the various civilian activities.

The former quarters of the Rome Army Corps H.Q., in Via del Pilotta, can no longer be used, in that the building - still requisitioned by the Allies - must be returned, upon derequisitioning, to the Vatican.

Moreover, from what can be seen from inspections and information gathered, it appears that when :

- the present H.Q. of the Prefettura,
- the ex-H.Q. of the Ministry for Post War Assistance in Piazza Nicosia,

become available, they will be hardly suitable both because of their location and because of their availability of premises for the requirements of the functioning of the H.Q.

Finally, when, following the transfer of the displaced persons which are at present occupying part of it, which transfer could be arranged as shown in para. 1, the Palazzo Braschi becomes available, it could, after adaption and renovation works, present, if not a complete and ideal solution, a solution sufficiently corresponding to the requirements of accommodation for the territorial H.Q., and practically the ^{whole of the} directorates and offices under command.

In this case the remaining directorates and offices which cannot be accommodated in the Palazzo Braschi would have to occupy some premises in the Principe di Napoli barracks, altered for office use by means of suitable works.
